TOWN OF GRAY ROAD NAME APPROVAL APPLICATION

Application Procedure:

1. Return Completed Application to Assessor.



2. Entrance permit is required as well as an application for a new road sign these are separate applications.
3. Assessor working with Public Safety verifies Road Name availability and authority of applicant to change name.
4. Assessor passes form to next signature for approval.
5. Next signer continues down the list until final approval by Town Manager.
6. After final approval original is then returned to the Assessor for Road Numbering purposes, & file.
7. Assessor then gives a copy to the following:

Registrar of Voters
Public Works
C.E.O.

APPLICANT NOTE: After this application is finally approved, the applicant is responsible for changing some or all of the following:

- **Miscellaneous Licenses (i.e. Drivers License, Dog License, Hunting & Fishing license, etc.)**
- **Motor Vehicle Registration**
- **Voter Registration**
- **Tax Bill Address**
- **Postal Address**
- **ETC... Any other items affected by a change of Address.**
