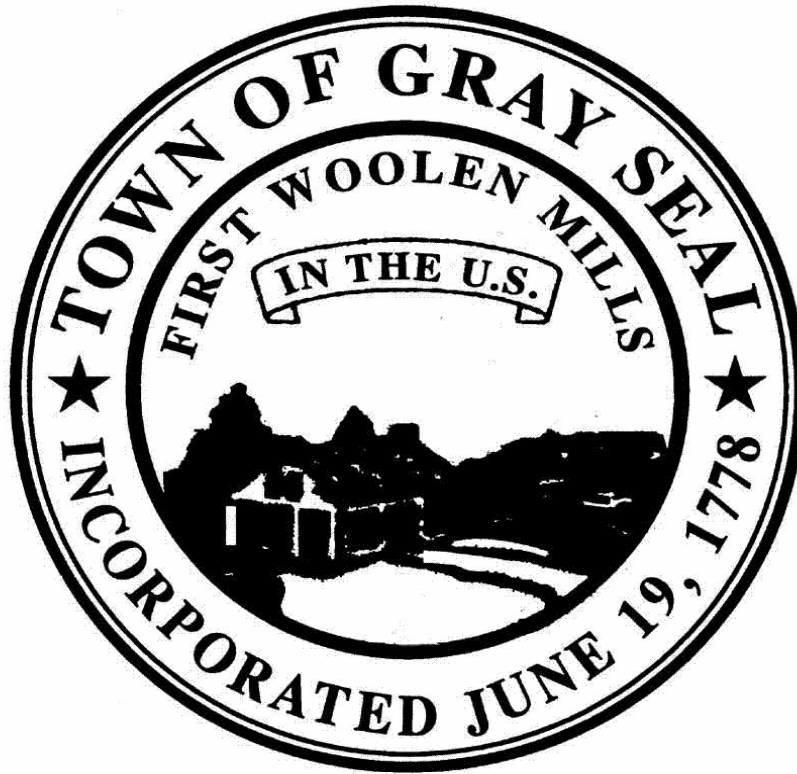

Gray Town Council Chair Report

Fiscal Year July 01, 2007-June 30, 2008

Greetings Fellow Citizens of Gray,

It is both my pleasure and honor to submit this year's Town Council report. The beginning of this year brought two newly elected councilors; Margaret Hutchins and Deborah S. Mancini. We joined the sitting councilors Marchian (Skip) Crane Jr., Alison Libbey and Andrew J. Upham.

This year marked noteworthy milestones for our town found in the following:

We put before the voters a municipal warrant concerning the previous council's (order #92-07) affirmed change to Gray's Comprehensive Plan adding a new section called "Area 8 Highway Commercial (Growth Area) which is designed to provide for highway oriented services and retail shopping opportunities to the community and visitors. This area is located where the Maine Wildlife Park Way a.k.a. Route 26-A intersects with Shaker Road a.k.a. Route 26. The voters overwhelmingly ratified this warrant item in the affirmative on July 31, 2007.

We authorized the Town Manager to enter into a contract with GEO Services (George Theborge) to provide the planning and economic development services for our town which has proved to be very beneficial in this area.

We were fortunate and grateful to have found resolution to the Pennell Institute situation that has been ongoing costly pursuit for nearly 17 years. Dr Alan Rich & Superintendent Victoria Burns on behalf of the Maine School Administrative District 15 Board of Trustees paved the way for the Town of Gray to accept the conveyance of the Pennell Institute and related Pennell Trust properties in exchange

for the Gray Public Library property, which is now held in the Pennell Trust. In return the MSAD 15 leased the library back to the town at \$1.00 per year with certain terms of a long term lease. Shortly thereafter Town Council moved forward with discussions that lead to directing the Community Economic Development Committee's charge to facilitate open discussions to find the best solution for the Pennell property.

The Village Master Plan Advisory Committee (ad hoc committee) was dissolved.

On behalf of the Town of Gray, Fire Chief Ricky Plummer accepted the gracious gift of a hydraulic rescue tool (the Jaws of Life) donated by the Poland Fire and Rescue facilitated by Fire Chief Willie Rice. This gives Gray two such "Jaws of Life" for emergency rescue procedures.

In the effort to retool the town's zoning ordinances, we made strides forward in the following areas; After establishing the Wellhead I and Wellhead II zones we discarded the Aquifer Overlay Zone (AOZ), the Village Aquifer Protection Zone (VAP). We enacted the Village Center Zone (VC) and the Village Center Proper Zone (VCP) along with Standards and Design Guidelines. We enacted the Business Transitional I and II zones (BT-1 & BT-2) and clarified other areas of the zoning ordinance.

We authorized the Town Manager to engage GEO Services (George Theborge) for a specified task of rewriting 402 Zoning Ordinance and 401 Subdivision Ordinance.

On behalf of the Town of Gray George Theborge submitted an application and we were subsequently awarded block grant money

from the Cumberland County Community Development Block Grant Program to help revitalize the Clark Block of the downtown area.

We partnered with the Maine Turnpike Authority to administer the bid process for Knight's Bridge on Mayall Rd of which proved to be a prudent decision and beneficial to the Town of Gray and has come to fruition.

We bonded the 3.2 million dollars of general obligation bonds to finance our Public Works Garage and addition to the town's Solid Waste and Recycling Building.

Our town is growing economically stronger by broadening our business tax base in a very positive direction. The Comprehensive Plan amendment allowing the growth area 8 district opened the gateway of progress for more businesses in that location. The Hannaford Brothers Company is bringing their newest supermarket complex to Shaker Road next door to the Gray Family Health Center.

Every year the Town Council hosts a Volunteer Recognition Banquet. This year we honored the following in their respective categories:

Clifton Foster – Lifetime Achievement

Jeanne Adams – Volunteer of the Year

Zoning Board of Appeals – Committee of the Year

Which included Barry Watson(Chairperson), Kyle Coolidge, Debby Flannigan, Vincent Palange and Kathy Wood

Bruns Brothers of Portland Rd – Private Organization of the Year

Richard Prince – The Evelyn Durgin Award

The budgetary process, be it long and arduous was both educational and successful

for those involved. The Town Manager Deborah Cabana lead the way as she put in order each of the town department's fiscal needs that then formulated her first draft of our proposed budget for Super Saturday. This is generally a Saturday in January whereby the department heads meet to present their portion of the proposed budget to the Town Council. From there we established goals. This year we set into play a series of televised Monday "Budget" Workshops for the purpose of involving as many key people and citizens to participate in the town's budget process. Though at times it seemed tedious work to bring each department into a general discussion, this proved to be a worthwhile mechanism. I hope that this process is critiqued and utilized in the years to come. The townspeople overwhelmingly supported our budget and all the articles at town meeting May 3rd and June 10th.

This year with the passing of her husband in Feb 2007, Town Councilor Alison Libbey resigned her post as Council Chairperson on September 4th. We appointed Tracy Scheckel in October to serve the remainder of this fiscal year as her replacement until the next election which was June 10, 2008.

On June 14, 2008 I, Deborah S. Mancini, resigned my seat of Town Council as Chairperson due to time constraint and private and personal reasons.

My personal wish is that this next year will continue to bring the citizens of our great community closer together for the greater cause.

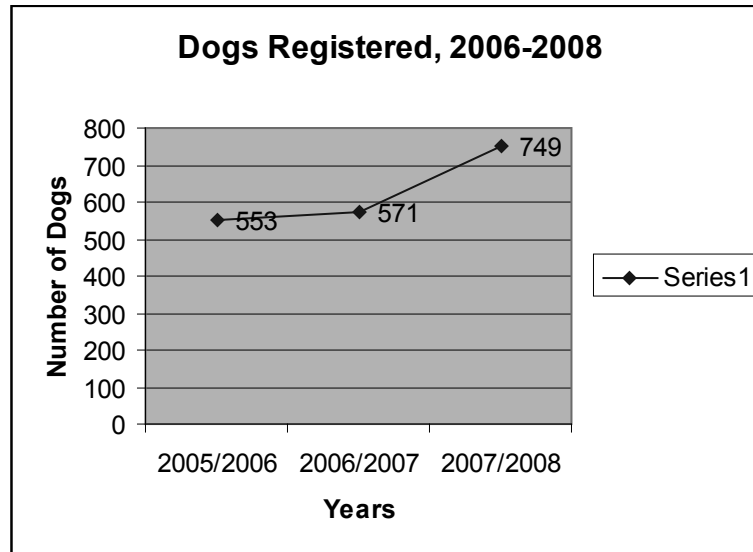

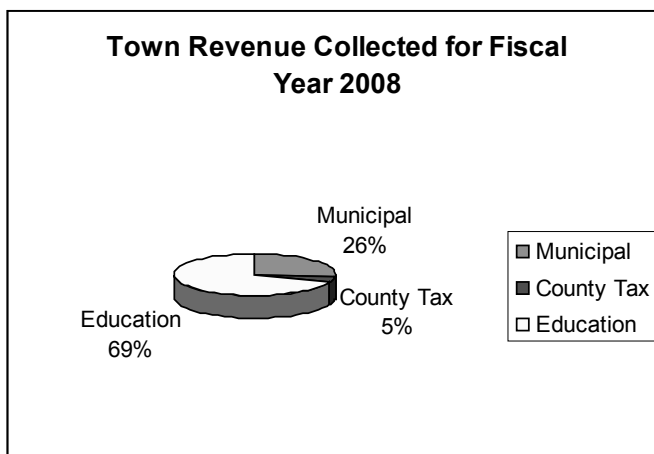
Annual Report by The Town Manager

Fiscal Year 2008

Greetings to All Gray Citizens;

It is my privilege to report the general administration of the Town during the fiscal year ending June 30, 2008. Despite the continuing economic downturn and the financial crisis faced by our state, many communities, and an increasing number of families, we can be thankful that the Town's financial condition is sound according to our audit reports. Past policies of fiscal restraint and careful management of funds and other Town resources have positioned the Town to weather the financial storms while continuing to provide needed services to our citizens.

The pie chart below reflects the revenues we collected for FY 2008. It also reflects what areas the Town is required to raise taxes: County, MSAD#15 and the Town and the distribution of those tax dollars.



The Town of Gray is quite healthy when viewed in a financial light. With a strong undesignated fund balance, the Town is in position to address ongoing capital investments without sharp increases in the tax rate while being able to weather short-term cash flows without having to borrow in anticipation of taxes. Annual auditing continues to test the practices and procedures of the Town's finances and prudent fiscal management continues to

demonstrate the need to anticipate and plan for major expenditures.

As the cross roads to the Lakes Region and with our strategic location between three of Maine's largest population centers, Gray continues to experience growth and change, and this past year was particularly active. By a narrow margin, voters approved an amendment to the Comprehensive Plan to designate the area at the end of the new highway bypass where it connects to Shaker Road as a business transitional growth area. With that change in the long-range planning policy, the Town Council approved a special zoning district designed to allow new commercial sites on that part of Shaker Road but to ensure that new uses are compatible with surrounding neighborhoods. This has been accomplished through enactment of the Town's first design guidelines that address building scale, landscaping, lighting, parking, and other site components for all commercial development within the new zoning district.

Major construction is currently underway in this new growth area on Shaker Road. Hannaford is building a new food store on the north side of Shaker Road following the previously mentioned design guidelines. Construction on the new Public Works Garage and expanded Recycling Center is also going strong, and those desperately needed facilities are expected to open in early 2009.

A less intensive but very important upgrade of our Public Safety Services also occurred with the relocation of the Main Street Fire Station to the former Walker Tire building on Turnpike Acres Road. The old station was inadequate to serve our modern fire fighting equipment and was located on our busiest intersection. A request for proposals to redevelop the Main Street Station was issued, and the Town is

working on plans to address parking, access, and septic limitations to facilitate redevelopment in keeping with the Village Master Plan. The management oversight of Public Safety Services is now the responsibility of new Fire Chief Rick Plummer, who stepped into the large shoes of the irreplaceable and much-missed Jon Barton. Chief Plummer became the Town's first full time Chief, another step in the Town's history.

While the Hannaford project will serve as a nucleus for new commercial growth in the Route 26 corridor, the Town is equally committed to commercial revitalization of the Village. That process took a major step forward when the Town of Gray concluded several years of negotiations with the Gray-New Gloucester School District to acquire the Pennell Institute and its nationally significant historic buildings. In addition to saving those buildings from continued deterioration and potential loss, the anticipated vote in November to invest in renovations to create a new Town Hall there, will open up the existing Town properties on Shaker Road for additional economic development.

The Town also successfully applied for and was awarded Community Development Block Grant funding to improve the "streetscape" of the historic Clark Block on Main Street. The front facades of the three commercial buildings just north of the old Fire Station will be upgraded with county funds and matching property owner investments. The utility poles in the sidewalk will be removed and those lines placed underground with new ornamental street lighting. A new brick sidewalk will complete the transformation of this prominent section of Main Street and will hopefully serve as a model to be followed by other property owners throughout the Village.

The Town's ability to pursue such ventures in planning and economic development has been enhanced by reorganization of the Community

Development Department to upgrade services and actively pursue implementation of the Comprehensive Plan and Village Master Plan. The Town contracted with GEOplan Consulting Services of Windham to provide planning and economic development services on a contractual basis and created a new position of Community Development Administrator to work in planning and code enforcement, while providing maintenance oversight for the Town's important public buildings. The hiring of a new Code Enforcement Officer rounded out a balanced team of professionals that will help dispel Gray's somewhat deserved reputation for sub-par development review services.

In addition to building the personnel capacity to manage development review and construction permitting, great effort was also applied to upgrading the Town's land use regulations to make them clear, consistent, and in compliance with state and federal laws. The antiquated Zoning and Subdivision Ordinances were overhauled, and the Town's aquifer protection regulations were refined to more effectively protect the Gray Water District's public water wells while removing overly restrictive zoning on other parts of Town, including Gray Village, that were hindering economic and residential development.

We are fortunate that the Council, our many volunteers and our staff continue to work towards the betterment of the community, especially with the challenges that growth brings and the special challenges we face in the current economic crisis. It is a great privilege to be working in my home community as we look to the future of the Town of Gray.

The Recreation Department (2 fulltime employees) is responsible for the coordination, supervision, implementation and administration of many activities, programs, facilities and special events for the benefit of the residents of Gray. Some of the responsibilities include; coordination of all recreation programs, daily maintenance of facilities (Wilkies Beach, Libby Hill Trails, Newbegin Community Center, soccer fields, basketball and volleyball courts), administer office duties (answering and returning phone calls, producing monthly/quarterly fliers and brochures, submitting news releases, processing registrations and fees, and making deposits). We are also responsible for setting up and taking down of the municipal voting. This department also coordinates all rental groups at Newbegin (we rent the gym and recreation room) for birthdays, school functions, special meetings/ events. We feel this department plays a critical role in the development and direction of our community. As our community population, needs and services grow; so should the growth of this department. We need improved facilities, new facilities and additional staff.

The library strives to give the citizens of Gray the best quality service available. During the last FY year the library has seen a 7% increase in its average daily circulation and a 22% increase in interlibrary loans.

Our programming continues to be strong. We participated in the state wide summer reading program, with a mystery theme. Among several activities sponsored by the GPLA was magician Denis Labbe who performed a mysterious magic show. Other programs this year were: Halloween Stories read by Glen Walton, a night sky event with Jay Sarton of the planetarium, festival of trees, gingerbread houses, valentines, young adult book group, the knitting group, as well as three regular story times with Kathy.

To better serve our patrons each morning our network automatically sends out notices to our patrons with an email address in our database two days before their items are due as a reminder. This feature has been well

We have also added three new subscriptions to our periodical collection that have been well received. They are This Old House, Everyday with Rachel Ray, and Maine Food & Lifestyle.

The trustees and I updated both the circulation policy and internet policy as well as adding an art exhibit policy. We also hope to implement a Birthday Club in the near future.

In March our new circulation desk was completed and installed. It was custom designed and crafted by local furniture maker David Klenk. While new, it gives it looks antique giving the library a new professional look. The new desk has allowed us to add a third computer to better serve our patrons at busy times of the day.

I would like to thank the fine citizens of Gray, the Town Council, Town Manager and all the Department Heads for their support and assistance during the past year. Without the continued support from all of you we, could not provide you with the service you deserve and expect. Over the past year I have become your first full-time chief. This certainly comes with big boots to fill serving after your long time fire chief, Chief Barton. Chief Barton was responsible for so much here at Gray Fire Rescue and certainly no one person could replace him. With that said, we certainly have tried to live up to his high standards and move the department forward. The officers and members of Gray Fire Rescue have stepped up to the challenge and moved ahead with providing more services, maintaining higher training standards and keeping up with our ever growing community.

Over the past year, we have formed a new partnership with the Town of Raymond who

We have had a very busy fire season responding to 10 structure fires. The help of our neighboring towns has been a huge asset. They are all to be commended and thanked for the assistance they have frequently given to us. In addition to having many structure fires, we were very busy with motor vehicle accidents mostly due to the bad weather we encountered during last winter. I want to thank Public Works Director Steve LaVallee for his hard work in keeping our roads passable and assisting us during the many storms endured last winter.

Our EMS and Fire Prevention weeks with our open houses have been a huge success. The members are to be commended for donating their time off. They continue to have our Fire Prevention and EMS week open house where hundreds of our residents learn fire safety and Emergency Medical Tips. I would like to especially thank Deputy Chief Ryan and Lt. Breault for their dedication to

Fire Prevention Week; it would not be possible with out their continued support.

Along with being busy with emergency calls, we have been busy with many projects such as going out to bid for a new Engine that is badly needed. We have worked with the Manager, Town Council and ultimately you, our citizens, to purchase the former Walker Tire building to replace the outdated village fire station. Jason Wilson was appointed by the town council to fill a full three year term, replacing Leigh Sullivan, who resigned in the Fall of 2007. Gary Foster was appointed by the town council to fill the seat vacated by Barry Sheff, who resigned in the Fall of 2007, whose term expires in July of 2008. Leigh and Barry were great board members who are truly missed by the remaining members. Many thanks for their years of service to the Town of Gray.

George Theborge was finally officially appointed as the Planning Board's consultant in late June of 2007. He replaced long time town planner Dick Cahill, who retired after many years of kind and courteous service to the Town of Gray.

The year was a busy one for the Planning Board, highlighted by the approval of the 36,000 square foot Hannafords grocery store and pharmacy on Shaker Road across from the school complex and the approval of the 40 lot Eagles Ridge subdivision on Eagles Nest Road in south Gray. Thanks to the support of the town's residents, a new Public Works facility was approved on Shaker Road adjacent to the public safety building. Modifications to the transfer station were also approved as part of the application. Other applicants that were considered and approved were as follows:

2. Gray Water District --- a minor subdivision on Yarmouth Road allowing the district to access an additional water source
3. Freedom Drive ---- preliminary approval was granted to this twelve lot major subdivision off North Raymond Road

Citizens and District Customers:

The Gray Water District is pleased to provide this report for our fiscal year ending December 31, 2007. Our Auditors, Clark, Friel and Joyce, PA have again provided an unqualified statement as to our financials for this period. The 2007 audit was conducted under the provisions of the GASB Statement No. 34. According to our audit, long-term debt decreased by \$89,226 and no new debt was issued during 2007.

During the year the District was involved in various, ongoing, preventative maintenance to the District supply and transmission lines. The Board of Trustees continues to pursue the development of a secondary water supply. The District worked in conjunction with the Town of Gray and Maine Department of Transportation to address potential road salt concerns within the public wellhead recharge area. The District recognizes the importance of protecting current water sources and identifying future water sources to satisfy the growing needs of the community.

The Board of Trustees looks forward to continuing its services to its customers and invites your comments and suggestions.

DEPARTMENT OF PUBLIC WORKS

To the Town Manager, Gray Town Council and the Citizens of Gray:

It is with great pleasure that I submit to you the annual report of the Department of Public Works:

The summer of 2007 proved to be another busy summer for the Department. The following roads were overlaid with 1- inch of hot top. Cambell Shore Road, Jenny Lane, Fran Circle, Upper Marginal Way, Partridge Lane, Graystone Road, Foster Hill Road, Two Rod Road, & Legrow Road. A total of 6,200 tons of hot top was machine placed to the 6.5 miles of roads. After the installation of shoulders for the above-mentioned roads, the Department spent the remainder of the season doing routine maintenance and repairing flood damage.

The winter of 2007/2008 was another challenging season and a good old Maine winter. Over the course of the winter we used 3,400 tons of salt, 8,500 yards of sand and 8,000 gallons of calcium. Our first storm was November 23, 2007 and our last storm was March 28, 2008. We had a total of 130 inches of snow. We had a total of 34 storms, causing 39 different plowing and sanding events and a total of 3,672 man hours, the majority coming on nights and the weekends, six of the mentioned storms being of the ice and freezing rain variety. The crew handled the many hours behind the wheel very well and severed the town with pride and dignity and all answered every one of my many calls.

On April 15, 2007 we experienced the Patriots Day Flood. The flooding rain caused severe damage to our infrastructure, damaging many roads and two bridges. The storm was declared a disaster by F.E.M.A. and we will recoup ninety percent of the \$175,000.00 worth of damages. The Public

Works Department spent most of the summer repairing the damage. I would like to thank the following people and businesses that assisted the town with support and services and help us to complete repairs after the storm, Gray Fire Rescue, Gray Fire Auxurily, Mike Barter, Nathan Tsukroff, Deb Cabana, Chris LaVallee, Holmes Excavating, Robert Skillings and Sons, Ed Milose, Paul White, Chris Bennett, F.A. Wing Paving, Floyd Wing, Mike Ryan, Portland Sand & Gravel, Colex, A.H.Grover Excavating, Whitney Tree Service, J. Maxwell Trucking, M.D.O.T., C.C.S.O., Maine State Police, George Flaherty, Charles Wasserloos of F.E.M.A., the crew at the Transfer Station, and our hard working crew at Public Works. All repairs were finished by November 2008.

We are presently taking a look at the second phase of our planned improvements which includes a new Public Work's Garage. Bids were awarded for the Public Works/Transfer Station Project in May of 2008 and ground breaking is expected to start by late July, the completed project date is scheduled for the first of 2009.

We also continue to strive to improve the infrastructure of the town including bridges and gravel roads. In July 2007 Mayall Bridge on Megquire Road was replaced. Knights Bridge on Mayall Road and Westwood Bridge on Westwood Road Bids have been awarded, with a startup date of July 15, 2008. Frost Road which is gravel will be paved during the paving season of 2008/2009, thus doing away with another costly gravel road.

As of July 01, 2007 the Public Works Department Crew consisted of William Horr, Arthur St. Cyr, Michael Toderico, Mike Morneau, and Michael Gervais [Full-Time].

Allen Tripp [Regular Part-Time]. Perley Witham, Floyd Wing, Will Plummer, Charles Kimball, and Michael Ryan [Part-Time Winter Maintenance]. All of our employees are very important to the town and Public Works would cease to operate without them. I am proud to be their Department Head and very grateful for their dedication to the Town of Gray. A major goal in the next couple of years is to add three more full time people to this hard working staff. One of the new staff members would be another full time mechanic and the other two positions would be on the highway side. The town is growing and such is placing a much greater strain on the department and we must have the staff numbers to meet this demand. Due to budget restraints in the past years the staff has been reduced and now staff has to start to be added back to cope with present day demands. One of these largest demands will come in 2010 when the DOT turns over eighteen miles of road to the town to maintain, we are struggling to maintain what miles we have now with our present staff. When I took over the Director's roll in 1994 we had seven full time positions on the Highway Department and one full time mechanic, presently we have four and one. The numbers must change if we are to keep our head above water.

Many thanks to Ed Milose, our maintenance head, whose constant support continues to bails us out of many situations.

Once again, I want to thank Chief Plummer, Chief Ryan, Chief Morrison, and the Department of the Public Safety for the many assists during the past year, the two Public Service Departments many times work as one and in very fine fashion. The Public Works Department and I want to wish a warm welcome to Rick Plummer our new Fire Chief and extend our gratitude to Bob Ryan and Gayland Morrison for a fine performance of leading the Fire-Rescue after the loss of our beloved Fire Chief Jon Barton. We would also like to thank the Maine State Police and Cumberland County Sheriff's Department for their many assists.

A big thank-you to all of the citizens of Gray who volunteer their time to serve our departments and committees and to all of the citizens who show courtesy toward to our department as we strive to improve the safety of our Town ways. And last, but not least, to Rona, Dianna, Helen, Elizabeth, Pam, Judy, Marty, Mitchell, Kinderly, and Doug, whose constant support makes and has made my job much easier.

Market prices for recycled material remained very strong throughout the fiscal year, which increased revenues received from the sale of newspaper, cardboard, mixed paper, plastics and metals from \$51,294 in FY 2006, \$63,054 in FY 2007, to \$96,239 for FY 2008! This revenue alone more than covers the wages of all full and part-time hourly employees at the facility. These monies, combined with those collected for the five-cent deposit bottles and cans, \$6,827, and disposal fees, \$57,355, total \$160,421 in revenue which goes directly into the Town's general fund balance serving to offset property taxes. Aside from the direct dollars recognized in revenue from recycling, had the roughly 740 tons of paper, glass and tin cans that were recycled been disposed of in the compactor instead, it would have cost the taxpayers almost 120,000 additional dollars in disposal fees alone. Recycling works!

Although the annual recycling rate for calendar year 2007 slipped a couple percentage points from the previous year,

52% for 2007 vs. 54.5% in 2006, it was primarily due to the difficulty of shipping some materials toward the end of the year. My goal for 2008 is for the Town to reach the 60% recycled mark and with everyone's help I believe this can be achieved.

I anticipate the recycling facility expansion to be completed in early 2009, a few months earlier than had been projected last year. When finished this will simplify the baling operation, freeing staff to be more attentive to you, the public; will provide heated space utilizing the waste motor oil disposed of at the facility; provide a separate enclosed room for a "swap shop", and my favorite, restroom facilities with running water and a flush toilet!

In closing, I wish to sincerely thank the members of the Solid Waste and Recycling Committee for their dedication and hard work, the volunteers who give so much of their time to help us at the facility, the Solid Waste staff for their commitment and positive attitude while performing some of the dirtiest tasks in town, and you the public for your kindness and support in making Gray a great town to work in.

Ordinance Review Committee

2007-08 Annual Report

The Ordinance Review Committee began FY 2008 continuing work on the Zoning Ordinance revision project, and commencing work on proposed language for a Village Center district to replace the Village Aquifer Protection district in Gray's Zoning Ordinance. The Village Master Plan Advisory Committee attended some of the meetings to assist in the Village Center district project.

A proposed use matrix for all districts, with minor amendments to the definitions to reflect changes in uses was completed in March.

The committee also reviewed a proposal to repeal the Aquifer Overlay Zone, supporting this proposal, and reviewed the proposed Business Transitional districts drafted by planning consultant George Thebarger. These two proposals amended the Zoning Ordinance to allow business development in the vicinity of the Public Safety building, in conjunction with the newly adopted "Area 8" amendment to Gray's Comprehensive Plan.

A proposal for a fire suppression ordinance was submitted to the Committee for review. The Committee recommended amendments to

the proposal, but did not receive an updated draft for review.

The Council submitted for review a proposal to amend section 402.25-G of the Zoning Ordinance to allow an exception to the established limits of de-icing chemicals in the Wellhead districts.

The Committee commenced reviewing the proposed rewrite of Gray's Subdivision Ordinance, drafted by planning consultant George Thebarger. As this was a new ordinance and not a revision to the existing ordinance, the Committee undertook an extensive review, which carried us through to the end of FY 2008.

Building and Grounds Department

Annual report for year ending June 30, 2008

Gray is a growing community and more tasks are being handled by the Building and Grounds Department. We do our best to keep up with the needs of our growing town, but with the shortage in staff, it is hard to meet our growing needs. Having to maintain a tight budget, some projects have been put on hold. With added responsibilities given to the Building and Grounds department, our department needs to grow with the demands. Volunteers willing to lend a helping hand with projects around town are always appreciated. The Building and Grounds Department currently employs one full-time employee, one part-time employee who fills a 32-hour per week position, one full-time seasonal 40 hour, 10 week position.

The following projects have been completed for fiscal year ending June 30, 2008:

Town Office

- New handicap ramp
- New paint on wood trim
- New gutters and down spouts
- Water proofing
- Repointing of brick area around the bulkhead
- Installation of a new door

Newbegin Gym

- East wall had to be re-pointed and water proofed.

The following are projected plans for fiscal year ending June 30, 2009:

Public Safety Building

- Creating new office spaces
- 2nd floor bath room
- Expanding the existing kitchen area and bring up to building codes
- New floor in conference room and halls
- New outside gutters and downspouts

Other buildings:

- Pennell Property – projects pending
- New Public Works building – as needed
- Transfer station addition – as needed

The Building and Grounds Department helps maintain 18 buildings and the surrounding grounds. Our responsibilities consists of landscaping and general maintenance at Wilkies Beach, five “Welcome to Gray” signs, the monument area, Newbegin fields, Douglass field in “Little League” off season, Pennell grounds, the outdoor basketball court area, and summer set - up for the Recreation Department. The Building and Grounds department also assists other departments (Public Works, Transfer Station, and Recreation Department) when they have a shortage of staff. During the colder months we are busy with snow removal, salting and sanding. During this time especially, I would personally like to thank all departments for their help; it is greatly appreciated. There are always other miscellaneous projects to attend to during the year also. This year with the price of gas and oil so high, we are trying to conserve in every possible way.

CEDC Annual Report

July 2007 – June 2008

To the Citizens of Gray:

The Community and Economic Development Committee meets monthly to discuss opportunities to improve the economic vitality and community atmosphere of Gray. Our meetings are held the third Wednesday of the month beginning at 6:30 PM at Stimson Hall. We cordially invite the public to attend a meeting and participate in these activities.

The activities and initiatives of the committee from July 2007 through June 2008 are summarized below:

Business Development:

Provided input regarding proposed zoning ordinance changes and architectural design standards. No feedback was given by Council.

Worked with George Theborge, Town Planning Consultant, to complete an application for a Community Block Grant for the Clark Block on Main Street and pedestrian crossings on Main St along with a pedestrian pathway from Hancock Street to the Gray Plaza – Applications were received and a grant of at least \$135,000.00 has been awarded as long as the town provides matching funds of \$55,000.00

Other Activities

Received charge from Council to assess the possible future uses of Pennell and other town owned buildings. A survey was drafted and sent to townspeople for feedback focusing on Pennell and

Stimson. A report of the survey results was generated and provided to the Town and Council Members. The Council subsequently directed the committee to focus exclusively on Pennell and two possibilities, renovation/alteration of the building for a new Town Hall campus or building a new Town Hall elsewhere.

Discussions with Ted McDonald are in the process to develop a film about Pennell.

The triangle area between Yarmouth Road, Brown Street and Main Street were discussed with the idea of downtown beautification. Another area discussed was Route 100 south where the MDOT is located. Activities involved discussions with landowners.

Long range road strategies are being discussed but no action steps have been taken.

Membership Status

Jeanne Carpentier is Chair, Ralph Wink is secretary. Jack Goosetrey, Don Hutchings and Tom Delaney are members. Tracy Scheckel acts as Council liaison.

The CEDC continues to recruit citizens of Gray to join the committee.

I thank the members of the CEDC for their continued commitment to fostering economic development in Gray.

DEPARTMENT OF COMMUNITY DEVELOPMENT

ANNUAL REPORT JULY 1, 2007 TO JUNE 30, 2008

The Town of Gray did a major reorganization of the planning functions with the creation of a new Department of Community Development. The position of Town Planner as a full time staff component was eliminated and the Town contracted its planning services with GEOplan Consulting of Windham, Maine. George Theborge AICP currently serves as an economic development director on a part time basis, and he reviews project plans submitted to the Planning Board under a peer review arrangement that bills applicants directly for the services provided by the Town. Under this new arrangement the efficiency and productivity of the department dramatically increased as indicated by the following accomplishments:

ZONING CHANGES

Business Transitional District – In keeping with the referendum results of the vote on the Area 8 rezoning, a special mixed use zoning district was enacted along Route 26 from the new Bypass to Libby Hill Road. The new Hannaford food store will anchor the new development of this area and will be subject to special design guidelines and zoning restrictions to reflect and protect surrounding residential neighborhoods, while connecting them to the commercial services with sidewalks.

Aquifer Overlay Zoning – Since the 1980s Gray has had overly restrictive zoning originally enacted over fears of contamination of the public water system's groundwater supplies. Working with the Gray Water District, the Town reviewed more accurate hydrological studies to develop a clearer understanding of the area around the Town's

water supply wells that is potentially vulnerable to contamination. Protections within the well recharge zones were increased, while the rest of the Town reverted back to the underlying zoning to allow reasonable development of property. These changes included rezoning of most of Gray Village, which is critical to revitalization of the downtown.

SITE PLAN APPROVALS

Hannaford Food Store – The Planning Board granted site plan approval for a new 36,000 square foot food store at the intersection of Shaker Road and Libby Hill Road. The new store will be set back several hundred feet from the road and will have extensive landscaping along the road corridor. Two smaller retail or office building sites along Shaker Road will also help the larger building fit within the neighborhood context. The Libby Hill Road intersection will be improved with a traffic light, and sidewalks will connect from that intersection to the High School and to the mobile home park across the street from Hannaford, improving traffic and pedestrian safety in the area.

Bruns Brothers – This truck servicing company doubled its size on Portland Road with the construction of an 8900 sq. ft. second building, which was built on existing developed portions of the site.

DPCMK Inc. – This sprinkler system company received approval to construct a 15,000 square foot office, service, and retail building on Lewiston Road north of the auction center.

Pollard Rand – The Planning Board granted site plan approval for a mixed use development next to the Spring Meadows

Golf Club. The first phase will be a new 3000 square foot credit union.

Dead River – The convenience store at Dry Mills was approved for an 1800 sq. ft. expansion that will house materials and equipment previously stored outdoors. The parking lot and entrances were improved as part of that site planning.

Public Works Garage – A new maintenance building and repair garage was approved beside and behind the Public Safety Building on Shaker Road. The building design was modified during the site plan approval process to respond to the new business transitional zoning applied to Hannaford. The storm and wash water systems were reviewed and modified to address concerns of the Gray Water District for discharges into that most susceptible portion of the water well aquifer.

Twinbrook Campground – The Planning Board undertook a thorough review of the campground expansions for this property on Little Sebago Lake. The Board heard testimony from concerned neighbors and worked with the campground owners to identify improvements needed to bring the property into compliance with zoning requirements.

New Retail & Service Establishments – The Board granted site plan approval for change of use in several commercial buildings, including three nail salons and a tattoo studio, a dog day care, coffee shop, and a driving school. The process for approval of such use changes will be streamlined under new ordinance revisions currently in progress.

SUBDIVISION APPROVALS

The Planning Board granted final approvals to several housing projects that had been under review in previous years:

Whitney Ridge – A 5-lot subdivision on Whiney Road.

Maple Ridge – An 18-unit, age-restricted housing project on Portland Road.

Orchard Knoll – A 24-unit, age-restricted housing project on Yarmouth Road.

Chestnut Heights – A 24-unit cluster subdivision on Mountain View Road.

Eagles Ridge – A 40-unit cluster subdivision on Eagles Nest Road.

Field Way – A 4-lot subdivision on Northern Oaks Drive.

ORDINANCE UPDATES

The Town Council authorized a project to update the Gray Subdivision Ordinance and Zoning Ordinance. These important land use ordinances were seriously outdated and inadequate to deal with the issues involved in development projects. Draft ordinances were prepared that are internally consistent and in keeping with State and Federal legal requirements.

DOWNTOWN REVITALIZATION

The Town of Gray successfully applied for and received a Community Development Block Grant to revitalize the Clark Block, a set of historic commercial buildings on Main Street next to the former Fire Station. Three building owners are being offered a matching grant to do façade improvements on the store fronts, and in the spring a public improvements project will place overhead poles and lines underground and install a new brick sidewalk and ornamental street lamps. This initial revitalization project will hopefully stimulate additional improvements throughout Gray Village.

Report of the Dry Mills School Committee

The guest book did contain quite a good number of signatures of people who stopped by during the summer season.

Before we closed the school last October, 6 classes from our own SAD 15, 3rd graders visited the school and were told about what it was like to attend a One Room School in the 1800's. The teachers were looking forward to bringing another group to the school in the Fall of 2008.

A Dedication Plaque has been made to place on the back wall of the school for Mae Beck with the following words along with her picture:

“Outstanding Service Award In
Recognition of Mae Beck

For her Dedication, Persistence, and
Untiring Effort in the Procurement

And Restoration of The Dry Mills One
Room Schoolhouse (1983-2004)”

May 13th, the Biddeford School Department visited the school with about 75 7th & 8th graders for a tour and presentation. Ms. Montambeau was the lead teacher and arranged for the students to be divided into 4 groups of between 15 to 20. They rotated between the Wildlife Park and the school. This was their 3rd year to visit.

In June, Miss Guerard's group of students from the Middle School spent a full school day at the school. Their lesson plans, lunch and recess were all planned around attending school in the 1800's. Miss Guerard brings her class about every spring before school closes.

A Structural Evaluation has been done and it has been determined that some repair work needs to be addressed in the near future.

Road Signs have been in the process of being made to place on the roads near the school to alert travelers of this Historic Building.

Town Council Rules as they relate to Dry Mills Schoolhouse Committee:

SECTION 602.29 - Dry Mills
Schoolhouse Committee

A. Establishment:

There shall be a Dry Mills Schoolhouse Committee consisting of eight (8) members appointed by the Town Council for three (3) year staggered terms.

B. Duties

The Committee shall preserve and protect the former one room eighth schoolhouse located at Dry Mills for the express purpose of maintaining as an education tool for school children and to serve as a local historical museum.

Presently there are only 3 members on the Committee. This Committee needs new members with new and great ideas to encourage group visitors as well as individual visitors and to establish a good list of Volunteers to allow this to happen.

With the approval of Hannaford this past year, the committee had communication with project engineers for input on sidewalks, crosswalks and other safety issues pertaining to the project. As the project moves forward the committee will continue talks through out the next year.

2008 REPORT OF THE GRAY HISTORICAL SOCIETY

Gray Historical Society is a 501c (3) non-profit organization dedicated, “to collect, preserve, and to share the history of the Town of Gray and State of Maine.” It was founded on June 6, 1962 by the Gray Grange as a committee project, and was incorporated in 1973. We would like others to join and become aware of the history around them. The meetings are held each month, except December, on the second Wednesday at 7 p.m.

Our research room and museum are rich sources of information about our town’s earliest days to the present and our volunteers take care in preserving our collections and making them available to the public. Visitors and researchers have come to the crossroads of Gray and to the first floor of Pennell Institute to discover answers to particular questions, to reminisce and enjoy and /or contribute gifts for our extensive collection.

Over the past year, we have:

- July 2007-June 2008 received well over 100 gifts for our collection.
- We welcomed 600+ visitors, researchers and responded to their requests person, E-mail, “snail mail”, or by phone.
- July 2007 held one day open house for Pennell Institute Reunion.
- Added several new members to GHS membership list, making a total of 123 members.
- July 2007’s, a 7 day open house was a success with over 100 people attending.
- Oct., Nov. 2007, presented programs on the Interurban at the Poland and the Cumberland Historical Societies.
- 2007 November, co-sponsored with the

Gray Fire Department and the Women’s Auxiliary, the annual lighting of the town’s Christmas tree on the Sunday after Thanksgiving.

- December, signed a lease from the Town of Gray Council to use the first floor of Pennell Institute.
- Designed a calendar as a fund-raiser, “A Walking Tour of Gray,” with photos of buildings at Gray center with historical information for each month.
- With help from members and several volunteers, the move to the first floor was accomplished in Feb., in time for the G.H.Society’s successful open House, Feb. 22 through 25.
- Feb., completed application form for requesting the nomination of Pennell Institute buildings on the Maine Preservation’s list of “Maine’s Most Endangered Historical Resources”.
- June 2008 two members of the Maine Preservation Committee toured Pennell Institution, its Lab building and the 1954 addition to Pennell.
- Received E-mail news and information weekly from the State and National Museum Associations.

Future Plans:

- Continue with the usual tasks of the collections and helping researchers in person or by mail and/or phone.
- Work on presentations for groups of citizens of all ages.
- Organize fundraising projects.
- Attend workshops to learn new ways to

update the collection, to collect, preserve, and to share the history of the Town of Gray and State of Maine.

- Continue reaching out to the community by fostering the appreciation of Gray's Rich Heritage.
- To investigate for available grants.

We still attend meetings of SOLVE Group to share activities, problems, and solutions with other small Historical Societies, and we maintain membership in Maine Archives and Museums and American Association for the State, Maine Preservation, and Local History.

All of our finances have come from dues, direct donations from visitors, and from profit of the sale of our unique items... books, T-shirts, maps, photos, postcards, Interurban trivets, bronze medallion necklaces, bronze coins, calendars, and magnets. Extra effort will have to go into fundraising projects, as these sources will be insufficient to cover the large amounts needed for our new responsibilities for overhead expenses.

President, Audrey Burns; Secretary, Lorraine Jones; Treasurer, Peggy Brown. Re-appointed as Curator Jean Szendrei; Membership Secretary, Lucille Stampon. The Board of Directors are Hubert Cobb, David Randall, Helen Davis, Karen Taylor, Leona Crooker, Janet Palmer and Don Whitney.

The HISTORICAL SOCIETY expresses its sincere appreciation to the Town of Gray Council for the Lease of the Pennell building's first floor. The Society would also like to thank Hall's Storage for the generous donation of a storage unit. We are grateful too, to all of our volunteers, including our officers and appointees, and those who have recently joined us in our tasks. A special thanks to Dean Bennett and all volunteers who helped with transporting the collection from the second floor to the first floor. Volunteers are always welcome, whether on an occasional or regular basis, and knowledge of Gray's history is not necessary.

All of the above continue to help us bring Gray's fascinating past to life!

To the citizens of Gray,

It has again been my pleasure to serve the people of Gray and Senate District #11 in the Maine Senate. I will complete my fourth consecutive term in early December; and because of term limits, can not stand for reelection. Thank you for the support you provided me at the polls.

FY08 was marked with good bipartisan cooperation in the Maine Legislature as both major parties came together to build common proposals for the supplemental budget to keep FY08-09 in balance. Two separate proposals were offered to bring the budget in balance. While the two offerings had more than 90% in common, they differed on limiting enrollment in Mainecare verses an increase on hospital tax and match. In the end, \$190 million in reductions were agreed to so that the FY09 budget is actually smaller than FY08.

The supplemental budget, along with jail consolidation and modifications to school administration consolidation as well as adoption of a statewide building and energy code, were the highlights of the second session

Looking ahead to January 09, the Legislature's major activity will be to build a new budget for the next biennial budget (FY10-11) and to continue to work on delivery of government services at all levels more cost effectively. This new budget will face many hurdles including:

- Complete unpaid bill payment to the tune of nearly \$200 Million to Maine hospitals for services provided to Mainecare patients going back several years.
- More than \$5 Billion in unfunded liability in State Employee Retirement and Retiree Health Plans.
- Trying to finally resolve the funding of the very expensive Dirigo Health Insurance Plan which I predict will be the subject of a successful People's Veto effort this November.
- Enhance transportation infrastructure repair funding and further shift toward mass transit options and advantage non petroleum offerings.
- Fund space heating options including conservation, warm space sharing, heating oil purchase for low income citizens.

Dear Neighbors,

It has been an honor to serve as your state representative during another very challenging year for our state. Continued budget constraints, drastic reductions in federal funding, and additional mandates from Washington have demanded the further reorganization of government services to improve efficiency, forcing the Legislature to make many more difficult choices this year. As your representative, I believe in being vigilant in considering the impact that the decisions we make have on our area.

While a handful of items took up much of our time and the public's attention, we enacted a number of laws this year that will continue to move Maine forward on important concerns such as health care access, consumer protection, energy, public safety, transportation and, most significantly, economic growth for rural Maine.

Some of these new laws will increase funding for bridge replacement and road repair, making a commitment to a strong transportation network. We also looked closely at expanding the use of alternative energy by adding a tax credit for geothermal heating systems and a rebate program for residential, commercial, and municipal wind projects. Further, for the first time in Maine history, we enacted uniform building codes for home and business construction and renovations, which will also contribute to energy savings in the future.
