

Note1:

Driveway design must prevent surface drainage from flowing onto or across the roadway. The entrance surface shall slope away from the road for the width of the existing shoulder, but in no case less than four (4') feet from the edge of the travel way surface.

Slope of shoulder must fall between: (.25"/ft.) per foot (Min.) (1"/ft.) per foot (Max.)
