Dear Friends,

It is an honor to represent Maine in the United States Senate. I am grateful for the trust the people of our state have placed in me and welcome this opportunity to share some key accomplishments from this past year.

As Chairman of the Senate Aging Committee, I worked to help ensure the well-being of our seniors. The *SeniorSafe Act* I authored became law last year and is empowering banks, credit unions, and other financial institutions to better protect seniors from financial fraud.

Following extensive committee investigations of prescription drug pricing, additional legislation I crafted became law, ending the egregious practice of pharmacy “gag clauses” that prevented pharmacists from informing patients on how to pay the lowest possible price.

This year, I was also successful in securing an extra \$425 million for Alzheimer’s research—the largest funding increase ever—bringing the total to \$2.34 billion. Additionally, the bipartisan *BOLD Act* I authored will create public health infrastructure to combat Alzheimer’s by promoting education, early diagnosis, and improved care management.

More than 40 million Americans—including 178,000 Mainers—are caregivers for parents, spouses, children, and other loved ones with disabilities or illnesses, such as Alzheimer’s. The *RAISE Family Caregivers Act* I authored was signed into law last year, giving caregivers more resources and training to better balance the full-time job of caregiving. Another law I wrote will help grandparents who are raising grandchildren, largely due to the opioid addiction crisis.

In addition to helping seniors, a major accomplishment over the past year is the increased federal investment in biomedical research that is leading to progress in the fight against numerous devastating diseases. Congress has boosted funding for the National Institutes of Health by \$7 billion in just the last three years, bringing total funding to more than \$39 billion.

One of my highest priorities as Chairman of the Transportation Appropriations Subcommittee is to improve our nation’s crumbling infrastructure and ensure that Maine’s needs are addressed. Since the Better Utilizing Investments to Leverage Development (BUILD) Transportation Grants program, formerly known as TIGER, was established in 2009, I have secured \$160 million for vital transportation projects throughout Maine.

Congress also delivered a Farm Bill last year, which includes many important provisions that will help the agriculture industry in Maine and across the country. Specifically, I secured provisions that will strengthen support for young farmers, improve local farm-to-market efforts, and increase funding for organic research.

Congress took decisive action to address the opioid addiction epidemic. In addition to appropriating \$8.5 billion in federal funding last year, Congress enacted the *SUPPORT for Patients and Communities Act*, a comprehensive package that embraces the multipronged approach I have long advocated for this epidemic: prevention, treatment, recovery, and enforcement to stop drug trafficking.

Maine plays a key role in ensuring a strong national defense. In 2018, Congress provided funding for five ships to be built at Bath Iron Works, which will help to keep our nation safe and provide our skilled shipbuilders a steady job. I also secured more than \$162 million for infrastructure projects at Portsmouth Naval Shipyard to support their important work to overhaul Navy submarines.

A Maine value that always guides me is our unsurpassed work ethic. In December 2018, I cast my 6,834th consecutive vote, continuing my record of never missing a roll-call vote since my Senate service began in 1997.

Dear Friends,

I hope this message finds you well. I am honored to represent you and your family and am grateful for the chance to offer both an update from Congress and my thoughts on the year ahead.

In Maine, we care less about political parties than about getting the job done. That's why I'm happy to report several recent victories I had reaching across the aisle to address issues important to our state.

Signed into law after months of deadlock, the 2018 Farm Bill contained several provisions I introduced. We were able to boost local food investment and organic research programs that are important to the Maine farmers driving a resurgence in our agricultural economy. The bill also created a pilot program to help doctors write prescriptions and offer vouchers to patients who need to change their diet but can't afford fresh food. Finally, the legislation included several steps I introduced to reduce food waste, a national problem that is not only costly to the environment and economy, but a missed opportunity to help millions of Americans who don't have enough to eat.

At the end of 2018, the President signed into law legislative language I introduced to assist veterans who had been blindsided by debt with the Department of Veterans Affairs. After hearing from several veterans who did not receive mailings about their debt until it was too late to take action, I introduced a bill to require the VA to improve its notification system. The final legislation requires that veterans have the option of getting electronic notifications and that the VA report on the underlying issues.

And on the House Appropriations Committee, I worked to protect programs that our state relies on, such as small business grants, rural broadband investment, effective responses to the opioid epidemic, shipbuilding at Bath Iron Works, and more.

As a new Congress gets underway, I will keep working with Republicans to make progress on key issues like these. But with Democrats now in the majority, I look forward to having an open debate on problems that have been ignored for too long. This includes the gun violence plaguing our nation, the dangers climate change presents to our country, crushing student loan debt, the influence of big money in politics, and the need for all Americans to access affordable health care and prescriptions.

In Washington and Maine, my offices stand ready to answer your questions, listen to feedback, and assist with federal issues and agencies. My hard-working staff helps many hundreds of constituents every year and I welcome the chance to serve you.

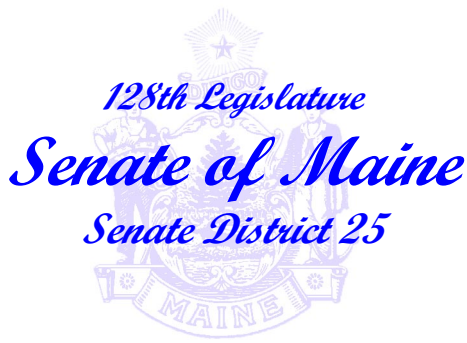
The election took place late in the first session and the Legislature adjourned just over a week later. Among the major accomplishments of the session were funding an expansion of MaineCare to cover low income Mainers that had been approved by Maine voters, increasing public school funding towards the goal of 55%, increasing the Homestead Exemption and Property Tax Fairness Program to provide relief for property taxpayers and passing a number of measures to safeguard Maine's environment. Our new state budget was enacted with broad bipartisan support.

The second session of the 129th Legislature will begin in January, 2020. The intense partisanship of recent years has diminished, resulting in greater collaboration and cooperation in addressing the challenging issues we face. Dear Residents of Gray,

Thank you for the opportunity to represent Gray in the Maine Senate. It is an enormous honor to serve this great community in Augusta, and I look forward to hearing from you as the 129th Legislature progresses.

As Chair of the Appropriations and Financial Affairs Committee, I can report that we produced a sensible and fair biennial budget that addresses many of our top priorities. I am proud that we provided much-needed property tax relief in the forms of an expanded homestead exemption, a more inclusive Property Tax Fairness Credit and an increase in municipal revenue sharing.

Additionally, we increased education funding to support our youngest students all the way up to our college students and adult learners, made vital investments in services for seniors, children and Mainers living with disabilities, enacted new environmental protections and set aside savings for the future by putting money in the Rainy Day Fund. This work was done on time and in a civil, respectful manner, with over 99 per cent of the initiatives receiving unanimous votes.

As always, I like to use this space to remind folks about unclaimed property, or money owed to Maine people by third parties, such as former employers, banks or utility companies. It could be from a forgotten account or uncollected wages, and could be unclaimed as a result of a change in name, addresses or bank account. Go to www.maine.gov/unclaimed or call 1-888-283-2808 to see if the state is holding any unclaimed property for you.

Finally, if you know of any students who have an interest in experiencing the legislative process first-hand, consider referring them to the Senate Page Program. Pages assist legislators by handing out documents during the session, passing messages between senators, and performing other important tasks. Families can make a day of it by touring the State House and other nearby attractions. Please contact my office and I will arrange a visit for when the Legislature reconvenes in January of 2020.

Hello to my fellow citizens of Gray Maine,

It has been an honor and a privilege to lead the Gray Town Council during this past fiscal year, and it humbles me to be in the position to offer this Town Council's Annual Report.

It is the responsibility of the Town Council to administer and set Policy on behalf of our town, while recognizing that we leave the execution of these Policies in the capable hands of our Town Manager and her professional staff. I and my fellow Councilors have thoughtfully and diligently worked to the best of our abilities to serve and improve the Town of Gray.

While conducting Council Business, we continued an experiment that was started recently to bring a more structured Program Management methodology to our deliberations, and I am proud and pleased to report that this experiment is paying off. We have successfully moved away from the potentially limiting question: "what are this year's 3-4 goals going to be?" We now review at the end of each meeting how we are doing on all our goals. We are managing a higher volume of projects with more detail and accuracy and have better accountability and ability to track progress across all our tasks and priorities. Our Task List provides a means for new Councilors to quickly come up to speed with the rest of the team on projects of importance. We are also using it as a record of past issues and decisions. It is also serving to prevent backtracking and repetitive discussion of issues that have already been put aside either for future work or dismissed altogether. We believe this tool will continue to be a valuable legacy tool for future councils.

Here is my summary of what this year's Town Council has accomplished, with the aid and support of Town Staff and many volunteers.

- Established the road map for updating the Comprehensive Plan for the Town of Gray, including the initiation of a town-wide committee and selection of an expert consultant to lead and facilitate this important effort.
- Updated the Contract Zone Agreement Policy to add additional steps before presentations are made to the Council to ensure financial viability of developers, ensure benefits for Town are front-loaded and ensure environmental and traffic impacts are fully identified upfront during Council's first review.
- Conducted a letter campaign contacting 1,000 residents, resulting in a comprehensive update of town records regarding Private Road Associations. This initiative also served to update affected residents regarding the need for associations as well as timely communication with the Town regarding winter

road maintenance.

- Coordinated with MTA to complete two new maintenance ramps in Gray - one on the Dutton Hill Road and one on Weymouth Road.
- Completed work on numerous Ordinances to provide better protection and guidance for the residents of Gray, notably:
 - Update of the Fireworks Ordinance to allow for appropriate and fair enjoyment of fireworks surrounding the July 4th weekend.
 - Approval of updated Ordinances to bring the Town into compliance with State statutes in the areas of Rescue Billing, Cable TV policies and Tax-Acquired Property procedures affecting residents 65 or older.
 - Update of the Street Ordinance to clarify authority when applying driveway standards on public vs private roads.
- Continued to monitor ongoing changes at the State level regarding Medical and Recreational Marijuana, reviewed policy decisions and adjusted Ordinances accordingly to ensure Town of Gray compliance with State statutes surrounding this complex and still evolving issue.
- Initiated workshop discussions with the Planning Board to share information, to identify opportunities to improve and clarify Ordinances and to generally improve communication between the Council and the Board.
- Approved new fee structure for building permits to compensate for transition to online code enforcement software which was approved through the budget process.
- Held a TIF (Tax Increment Financing) infrastructure workshop to identify and prioritize top projects.
- Continued efforts to apply Program Management methodologies to improve the Budget process and timeline, including the initiation of a budget specific tracker to identify cost drivers throughout the year for review during the budget cycle.
- Reviewed and approved an update to the existing Bike/Ped plan.

Recognizing that we could do none of this without the support and the active involvement of the citizens of Gray as part of the team, I would like to extend a big “Thank You” from me and the rest of the Town Council to the many volunteers who give willingly and tirelessly of their time and talents to keep our many committees focused on the goal of a better Gray for all of us.

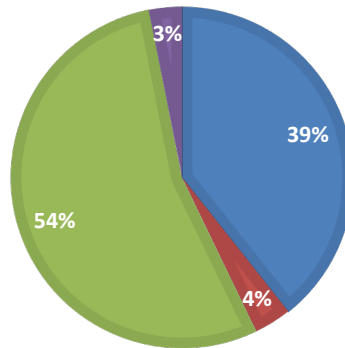

Equalization/Revaluation Update:

The Equalization/Revaluation Project was completed in July of 2018. The new assessments will be reflected on the tax bills due October 1, 2018 and April 1, 2019.

Property Tax Relief Programs

The following programs are made available to taxpayers at the local level. Applications are located in the Assessor's Office and on the Town of Gray's website www.graymaine.org. Applications must be filed on or before April 1st.

Homestead Exemption: To qualify, homeowners must have owned a homestead in Maine for a minimum of 12 months prior to April 1st and declared the homestead to be their permanent place of residence. Once the application is filed, the exemption remains on the property until the owner sells or changes their place of residence. This exemption provides up to the whole value of \$20,000 of taxable valuation exemption.

Veteran's Exemption: Any veteran or the widow/widower of a veteran, who has reached the age of 62 and served on active duty during a federally recognized wartime period may be eligible for this property exemption. Veterans under the age of 62 who served on active duty during a federally recognized wartime period must be receiving a pension or compensation from the US Government for total disability. This exemption provides up to the whole value of \$6,000 of taxable valuation.

Blind Exemption: Individuals declared legally blind by a medical doctor or eye care professional may be eligible for this exemption which provides up to the whole value of \$4,000 of taxable valuation exemption.

Property Tax Fairness Credit: This program is administered by the State of Maine and applicants may file for this refund program as part of their State of Maine income tax return.

Business Equipment Tax Exemption (BETE): Certain businesses may qualify for an exemption on personal property tax for equipment first subject to taxation on or after April 1, 2008. This exemption is not an automatic exemption and must be applied for annually.

Business Equipment Tax Reimbursement (BETR): Certain businesses may qualify for tax reimbursement from the State of Maine on personal property tax paid during the previous year. Taxpayers begin the application process by filing an application form with the local assessor's office, followed by the filing of an application form with Maine Revenue Services. This reimbursement must be applied for annually.

Property Valuation

Property is assessed based on the status of the taxpayer (eligibility for tax exemptions) as well as the location, condition and taxable status of the property as of April 1st of each year in compliance with state statute.

Mobile homes are considered to be real estate for property taxation purposes. An individual buying, selling or moving a mobile home is required to contact the assessor's office to provide information for the updating of ownership records.

The Commitment book, property tax maps, and real estate transfer tax forms are public records and are available for review at the town office. Citizens are welcome to call or visit the office at any time during regular office hours.

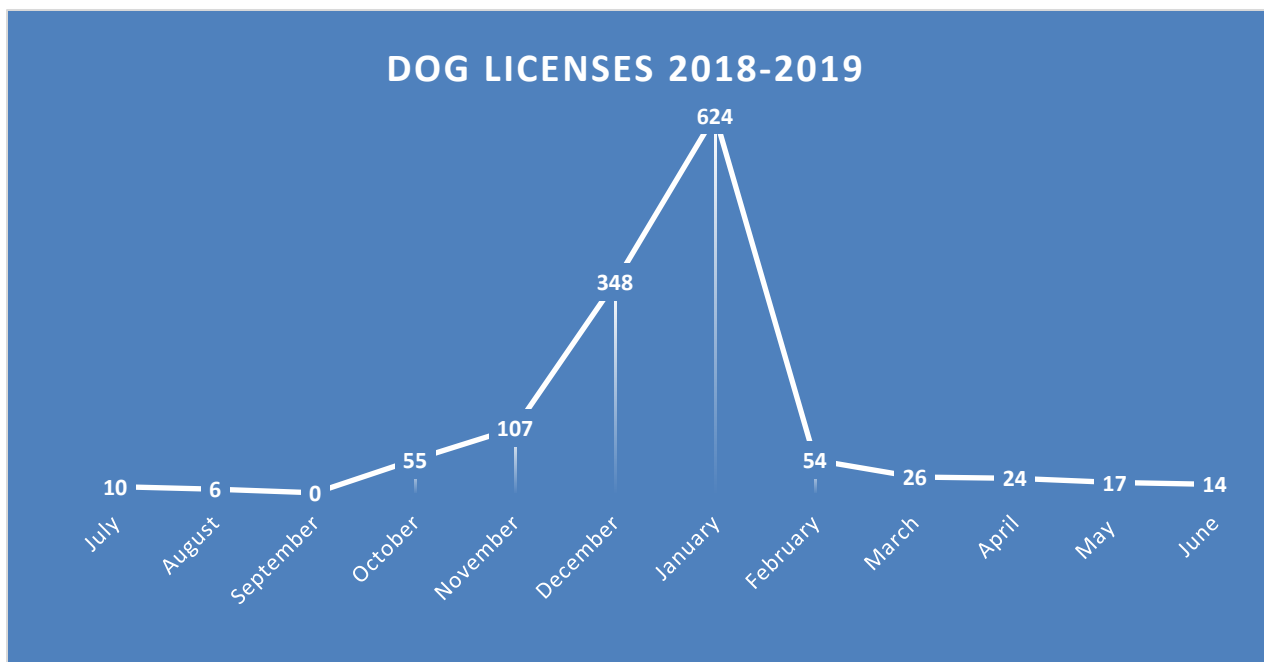
ANIMAL CONTROL ANNUAL REPORT

July 1, 2018 – June 30, 2019

ANIMAL CONTROL: DOG LICENSING

State law requires all dogs aged 6 months or older to be licensed in the State of Maine. Dogs can be licensed at the Gray Town Office in person or online (October 15-January 31) at https://www10.informe.org/dog_license/ Fees for neutered / spayed dogs are \$6 per year, while non-neutered / non-spayed dogs are \$11 per year. All dogs must be licensed no later than December 31st of each year and a \$25 late fee will be charged beginning February 1st.

A total of 1,285 dogs were licensed last year. By licensing your dog, **YOU** are directly helping the fight against animal cruelty and abuse. Up to 90% of the dog license fees collected go directly to the State of Maine Animal Welfare Program to support cruelty investigation. Licensing your dog also helps to insure public safety by requiring proof of a valid rabies vaccination before a license is issued.



Annual Report for the 2018 Gray Blueberry Festival and planning for the 2019 Gray Blueberry Festival

The Town's 3rd annual summer festival continues to take place on the second Saturday in August; this year it was held on August 11, 2018. Because of the generous support of our returning and new Gray business sponsors, there was no admission charge in 2016, 2017, 2018, (and for 2019). The 2018 committee kept the tag line: *Celebrating Community, Connection, & Culture*, whereas the 2019 committee decided to shortened the tag line to: *Celebrating Community & Culture*.

Hours and location: In 2018, the festival kept the same hours of 9:30 am to 3:00 pm at the same location - 24 Main Street, Gray. This year, events took place both inside and behind Newbegin Hall, and inside and behind the Town Hall, including (2) staff-led tours of Town Hall building and the historical Clock Tower. For 2019, the committee extended the ending time to 4:00 pm, and incurred additional expenses for another hour of EVO rental.

Parking and traffic control/pedestrian safety: Parking for both vendors and attendees continues to be across the street in the large open field at 35 Main Street, overseen on the day of event by G-NG High School Booster Club (who ask for a \$5 donation). The large blacktop parking lot in front of Newbegin Hall was reserved for booth/display of: a Gray Fire Engine, the 1932 Fire Truck, Cumberland County Emergency Management Association, and for handicapped accessible parking. There were some complaints by these handicapped drivers when backing out, into the oncoming pedestrians and horse-drawn wagon. For 2019, we would move the location of the handicapped accessible parking.

Greeters & attendance: The G-NG Lion's Club returned for their second year as the festival's official Greeters. More programs were printed (up from approx. 300 programs in 2017 to 600 programs in 2018) and Town staff added a QR code for people who might want to download the program through their cell phones. We also doubled the volume of wild blueberries given away as small samples, thanks to a grant from the Wild Blueberry Commission of Maine. For 2019, we secured the same grant and additional sponsorship which would allow us to purchase even more locally sourced, fresh wild blueberries to be given out as small samples to the adults as they entered the festival. Children and teens received a bumblebee hand stamp.

G-NG Lion's Club once again tallied the number of people attending the Festival. In 2018, there were approx. 350 more festival goers and 50 more festival "workers" (1,850 and 150 respectively) than the year before. For 2019, the committee was planning for 3,000 in attendance, and increased things such as the number of tables and chairs rented, renting a larger tent for the stage/bands, and increased the number of porta potties rented from 3 in 2018, to 4 for 2019, and purchased (3) hand-held tally counters.

Logistics: This annual summer event continues to retain much of the same flow of events and small town feel since it began in 2016. There were however considerably more crafters, and more food vendors in 2018 and planned for 2019. Even still, the festival continues to need more food trucks than have been secured each year, the food trucks either run out of food, and/or have long wait lines.

2018 Revenue & Expenses: The 2018 festival raised approx. \$4,500 through the generosity of 20+ sponsors, plus several hundred dollars' worth of in-kind donations; and approx. \$2,500 in fees from EVO ticket sales, t-shirt sales, and booth fees. The 2018 committee created a \$100 Sponsorship level that appealed to several new sponsors. Because of the increased revenue from these other sources, we were able to decrease the Town of Gray's contribution to approx. \$950, which is \$600 less than the year before. The Town also continues to be the Host (e.g. insurance waivers to run this large community event, and allowing staff administration time to help with small facets of the festival planning such as running background checks on new volunteers). Total revenue and expenses for 2018 was just over \$8,000, about a \$1,000 more than 2017. The largest expenses for 2018 and for 2019 continue to be:

EVO equipment rental, tent rental, musician fees, printing t-shirts (for volunteers and for sale), printing marketing materials, and renting the horse drawn wagon rides.

The budget for 2019 was expected to increase several hundred dollars. By June of 2019, the Festival had secured commitments for the same total revenue as 2018 from of Gray business sponsorships, with the exception that two returning sponsors increased their sponsorship level, there were four new \$100 sponsors although less \$100 sponsors than in 2018. For 2019, Enercon Technologies increased their sponsorship level from \$500 to \$1000 and became the Presenting Sponsor.

The committee kept the vendor booth fee at \$30 and non-profit booth fee at \$15 for 2018. For 2019, the vendor booth fee would increase to \$40 while keeping the non-profit fee at \$15. For 2018, the committee sold logo-printed canvas tote bags in addition to white T-shirts for adults (which ran small), and blue T-shirts for youth. Each volunteer received a new blue cotton T-shirt, with the hopes that he/she would wear the same volunteer T-shirt in 2019. For 2019, the committee decided to purchase unisex, blue T-shirts for adults to sell, and would lower the price from \$15 to \$11, to reduce the inventory of T-shirts and tote bags left over from 2017, 2018, and 2019.

Activities: Building on the successful activities* already being offered, in 2018 we added: DIY sign making and water color workshops inside Newbegin Hall; a bee keeper and a basket maker out in the field/booths; Pennell Clock Tours (mentioned earlier in this report); a Corn Hole course (to help promote the sponsors); and offered both a morning & afternoon pie eating contest (20 6" pies in all, 10 more pies than 2017). Pies were donated by Pineland Farms and Giffords Famous Ice Cream donated a 6-month supply of ice cream to the pie contests' two winners. Rachel Lyn Rumson continues to oversee the Pie Eating Contests, with sign-up done through the Gray Food Panty who is the beneficiary of this fun-raising event. For 2019, a total of 30 6' pies will be donated by Pineland for the contests, and Giffords would award a total of four 6-month supply of ice cream - two for youth winners and two for adult winners of the morning and afternoon contests. For 2019, the committee still wanted to make better use of the two ball fields and would spread out what will take place in each field, and added a Scavenger Hunt/punch card with prizes awarded to get folks seeing all that there is to see. We added a fresh, wild blueberry vendor in 2018, and would move this blueberry booth to a more prominent location for 2019.

*Live music, horse-drawn wagon rides, dunk tank, fun run dash, diaper derby, old fashioned lawn games, and a kids' tent. Kids Tent was run in 2018 by Fiddlehead Center staff and volunteers, and would be run by Gray Recreation staff and volunteers in 2019.

Marketing: Every year, the committee is able to increase the number of press releases sent to local and regional Festival/Calendar listings, both online and in print. Renee Robbins took on this role for 2019 and did a great job! The number of event Facebook Likes, Followers, and Shared posts continues to increase steadily each year, just over 500 in 2018 and over 600 by 2019. For 2018, the committee was able to re-use the three large canvas banners and 40+ remaining vinyl lawn signs from 2017 by the use of stickers. New lawn signs were purchased for 2019 that were easier to read from the road. For 2018 & 2019, we hired a new event photographer, Heather Bennoti, whose photos are then used throughout the year for Facebook event page posts <https://Facebook.com/GrayBlueberryFestival/> and promotional pieces.

assisted with Friday set-up and Saturday day of event and clean-up. About half are returning volunteers which helps with continuity, and there are new volunteers, depending on who is on the committee each year that help make this event possible. Plus, a handful of Town staff help with the day of event programs and logistics.

Feedback and Thank-you's: Feedback is critical to build on the success of this small-town event. In 2018, we sent out the same electronic follow-up survey that Rachel Lyn Rumson had created in 2017. Feedback from: the survey, the Committee, Town Staff, and Town Council is then summarized in a SWOT analysis to help plan the next year's festival. Committee chair sent thank you emails to vendors, musicians, etc. and mailed thank you letters with a program to the Sponsors. Several returning sponsors received a surprise visit in the spring with home-made or bakery blueberry muffins.

*****Gray Blueberry Festival focuses on four main goals: 1) Celebrate and promote the Town of Gray, businesses, organizations, and Pennell Complex; 2) Build on existing, and foster new, collaborative efforts in town; 3) Create 'new childhood' memories and relive 'old childhood' memories of Gray's Old Home Days; and 4) Educate attendees by offering interactive activities and booths. Gray's Old Home Days took place for several decades and ceased operating in the early 1990's.*****

Buildings & Grounds Department



I am pleased to prepare the Annual Report for the Department of Buildings and Grounds. As this is my first year, I have learned a great deal about the wonderful Town of Gray.

The Building and Grounds Department is staffed by three full time 40-hour per week positions and a 24-hour week part time position. We are tasked with the maintenance of the facilities owned by the Town of Gray which include the Pennell Municipal Complex, Gray Public Library, Public Services Complex, Public Safety Buildings, Dry Mills Schoolhouse, Wilkies Beach and The Monument. The department works closely with the Code Enforcement Officer, Planning Department, Public Works, Transfer Station, Public Safety and the Recreation Department.

The maintenance crew is responsible for all aspects of care for the Town facilities. A few of those responsibilities are cleaning, mowing, shoveling, moving furniture, painting and the setup and take down of elections. There are always small projects and maintenance items to be performed.

Routine and preventive maintenance was completed on all HVAC systems. Septic systems were pumped at Public Works, Public Safety and the Library. Elevators in the Pennell Municipal Building and the Library received their required maintenance, testing, and licensing.

Projects completed in the fiscal year 2018-2019 included the following:

- New forced hot air furnace for the living quarters of the Public Safety Building
- Removal of old bleachers at the Pennell Fields and replacement with cement pads and aluminum bleachers
- Asbestos abatement of the Maintenance Building

I would like to extend a thank you to Steve and the Public Works crew for assisting us when we needed them. Their help has saved us from some hard digging on more than one occasion. I would like to thank the Department Heads and Town Staff for assisting me in this first year, especially Deb, Dean, Doug, Katy, Tom and Suzanna.

I would not have made it through this year if I did not have Wink and Roger. Their combined years of working for the town and being assistants in the Department have made for a smooth transition. Thank you for your hard work and dedication. I would like to welcome Carol to the crew as our part time staff member.

CEDC Annual Report FY 2019

During this reporting period, the CEDC members were Joel Robertson-Chair, Roger Dery-Vice Chair, Lacy Antonson, & a new member, Marissa Caminiti. The members were actively involved in several community building activities including a Buy Local Shop Local campaign, assistance and participation in the Gray Blueberry Festival 2018, and the creation of a “float” for the Memorial Day Parade called **Help us Plant** geared toward recruitment of short-term, project-based volunteers. They also hosted a Vermiculture workshop at the Gray Library. In addition, the CEDC continues to offer ribbon cuttings and sends Thank You letters to new or expanded businesses.

The group developed a new product during FY2017 and fine-tuned in FY2018, the Gray Welcome Booklet, which continues to be updated bi-annually and is available at Town Hall year-round, and at elections. This booklet lists all the Town departments, resources, and a calendar of events. It also has a “yellow page” listing of all the business on the online business directory. The Gray Welcome Booklet is also available electronically on the Town of Gray website in a PDF version: at graymaine.org/welcome.

The CEDC used this year to define their goals, prioritize their work plan, and hone their mission statement. Some of the projects that the committee is working on include sustaining the Buy Local Shop Local campaign, and Village Beautification (storefront beautification incentives, flagpoles/banners, streetscaping). They used their allocated funds for supplies to continue the publication of the Gray Welcome Booklet and for brackets, rods & hardware for pole banners which will be installed soon on the major arterials in Gray.

Future goals include pursuing Certified Business Friendly status and participating in the Comprehensive Plan update (traffic & land use). They have also discussed the possibility of creating a Business Guide, similar to the Gray Welcome Booklet, except directed towards business owners or potential new businesses with resources included on the planning process, demographics, and other information that might encourage commercial growth and support businesses already located in Gray.

The CEDC was designated as a 7-member committee and as such requires 4 members for a quorum. As a result, several meetings were cancelled which does make it difficult to gain momentum and complete projects. Due to this struggle, the committee with Council support was reduced to 5 members which requires a quorum of 3. We still covet additional members in this committee and welcome new applications. At the end of this reporting period, we received an application for a new member, Eliza Watson, who will start in August 2019.

The CEDC members are a dedicated group of volunteers with great ideas and skill sets. The focus of this group is to have a set of attainable goals, produce products, foster community involvement & pride, complete projects & support Gray business owners.

The annual meeting of trustees of the Gray Cemetery Association was held on September 26, 2018. Five year terms as trustees were approved for Galen Morrison [renewing] and Debi Curry [new] with terms to expire in 2022.

Discussion focused on the following:

- Funds have not been transferred to Perpetual Care investment account in recent years. Trustees anticipate this will be addressed in the FY2020 budget with corrective transfer to an interest-bearing account.
- Crabgrass has become an extensive problem throughout Gray Village Cemetery. Superintendent Chris Stilkey recommends a five-year program to repair the damage to include lime treatment and addition of grass plugs [Zoysia]. Additional trees for shade should be included in the plan. Motion was made and approved to begin aggressive treatments in spring of 2019 at an anticipated additional cost of \$3,000 annually.
- Property owners abutting South Gray Cemetery would like a new fence around the cemetery. They are willing to install if GCA provides materials. General approval to follow-up by asking the owners to seek out pricing to present to GCA for further action.
- General discussion about the possibility of adding a Veteran's Park at Gray Village Cemetery. Trustees felt that there is sufficient room behind the Town of Gray signage. Matter left open for further discussion.
- The Gray Cemetery Association wishes to extend their appreciation to Gwen Pollard for her years of fine service as the Association Secretary/Treasurer. Gwen tendered her resignation at the end of this fiscal year. President Robert Sawyer appointed Debi Curry to fill the Secretary/Treasurer position until trustees meet for a formal vote in the fall.

Preservation of our Past and Pathway to our Future

Annual Report to the Town Council

June 1, 2018-June 1, 2019

The mission of the Dry Mills Schoolhouse Museum Committee is to strive to fully restore and secure the Schoolhouse for posterity, to preserve its rich history, to open and present it to the public on a regular basis, to allow Gray residents, individual visitors, and student groups direct access to an educational immersion experience, and to provide a preserve for inter-mutual community and celebratory events.

The Committee's goals for 2018-19 were:

1. To continue fundraising efforts to assist with repairs, programming & preservation efforts.
2. To work with Town Staff, MSAD15 and Community Companies/Groups to help facilitate the needed DMS repairs and reopen the Schoolhouse in 2019.
3. To develop formal updated programming to establish long range visitation/support for the DMS working in collaboration with the Maine Wildlife Park.
4. To work with the Gray Historical Society to memorialize the Henry Pennell House at the DMS location as a first step to a possible Historical Trail which could connect the many historical sites in Gray into a cohesive marketing strategy with potential to add many other sites and groups (Libby Hill Trails, Narrow Gauge Railroad, etc.).

This past year has been another successful year for the Committee with work being done on all four of our 2018-19 goals. Through the Honor Plaque fundraiser, Avon Fundraiser and outreach efforts, the Committee raised \$1,217.57, bringing the account total to \$9,278.44 as of June 2019.

With the allocated Town funds of \$65,000, Town Staff has secured a contractor to lift the building in early Fall 2019 to begin the repairs. The carpentry work and timeline are still being planned, but the Committee has secured a commitment from the GNG HS ExCel class to assist in the effort.

In addition, the Committee began a partnership with the ExCel class to archive and catalog the current DMS programming material and historical documents/materials. The Committee met with the Windham Historical Society to share information and have a working list of new approaches and ideas for updating and expanding the DMS programming in 2020.

Once the DMS repairs are underway, the Committee will work with the Gray Historical Society to finalize the Henry Pennell House Memorial at the DMS. The GHS is hopeful to have their first History Walk Marker at the site of the original Henry Pennell House completed this year.

The committee's goals for 2019-20 are:

1. To continue fundraising efforts to assist with repairs, programming & preservation efforts.
2. To work with Town Staff, Volunteers and the ExCel class to assist with the repairs and plan a Grand Reopening for the Spring of 2020 including finalizing the Henry Pennell Memorial.
3. To continue the Archiving project and overhaul the DMS programming to coincide with the Grand Reopening. To work collaboratively with the Maine Wildlife Park to increase visitation to the DMS.
4. To begin a Memory Project to document first-hand experiences at the DMS to be used in future programming.
5. To work with the Gray Historical Society on a Gray Exhibit to be included in the Maine Bicentennial Celebration in 2020.

For nearly 60 years the Gray Historical Society has been collecting and preserving Gray's past. Our 2018-2019 fiscal was another busy one for our small band of historians and volunteers.

The addition of the Fire Museum honoring Gray Fire Rescue's 135 years in existence was a major undertaking that was completed during the winter. An open house in June introduced the artifacts and memorabilia telling the story of the brave men and women from Gray's past.

The Society's annual dinner meeting was held in April and featured a wonderful turkey dinner followed by guest speaker Phil Morse from the Seashore Trolley Museum. Mr. Morse presented a program on the Portland Lewiston Interurban trolley NARCISSUS.

A special research area was recently completed at the museum. The addition of a large antique table surrounded by Town records, reports, newspapers and many documents make for an ideal spot for historians, students and researchers.

Goals included completion of the Henry Pennell Memorial Park, and the development of the Gray Village historic walking trail. Members completed a Pennell Institute display in the upstairs of the Town Office which was opened to the Pennell Alumni at their annual banquet in August.

Thanks go to Don Whitney and Dick Skilling, who set up a table of historic artifacts and information at the Fourth Annual Blueberry Festival.

The society's board of directors will next explore a long-term goal of improved accessibility to the museum via the addition of an elevator to the second story.

Thanks to Gray Public Works Department for the paving of our parking lot and for keeping our parking lot open in the winter!

Gray Fire Rescue Annual Report

2018 – 2019

I want to start by thanking the Town Manager, Council and the citizens of Gray for their unwavering support of the Public Safety Department.

We expect our new Ladder truck to be delivered in August!

Last year we ran a total of 1133 calls. Midway through this season we appear to be on track to run between 1200 and 1300 calls. Drug overdoses and suicides continue to be disproportionately more common than I would think they should be for a town the size of Gray. I believe one reason is our geographic location being midway between Portland and Lewiston making the acquisition of controlled substances relatively easy.

Our current level of staffing is working very well and has accomplished what I had hoped it would. We have been able to cover the vast majority of our EMS calls with our own staffing, providing quicker, quality service to our citizens then if we had to rely on neighboring towns to help. I had also hoped the additional overnight person would help with the comfort level of our new basic EMT's. I believe this has worked. My method of measuring this is by the trend of our call membership levels. In 2016 we were at a low of 25 members down from a high of 48 in 2011. 2017 and 2018 saw increases in our membership with 32 at the end of 2018. As of this report we have 31 members.

I continue to work closely with Cumberland County EMA to prepare Gray for as many eventualities as possible. I welcome the opportunity to share risk concerns with the Manager and council as appropriate.

We continue to be quite successful in the grant arena. We have finished outfitting our gym at Central Station using the Assistance to Firefighters Grant. We have almost finished outfitting our EOC (Emergency Operations Center) using Homeland Security Grant funding. We will be purchasing more digital capable radios this coming year using another Homeland Security Grant award.

Gray, New Gloucester, North Yarmouth and Raymond have reinvigorated efforts to share resources and training. I am the Chair and Chief Toby Martin of New Gloucester is the secretary. Our current priorities are as follows:

1. Sharing radio frequencies.
2. Plan for grant request for moving to digital DMR.
3. Regional training.
4. Improving our training site.
5. Updating automatic aid agreements.

Again, thank you for your support and I look forward to facing the challenges to come.

The purpose of the Library Trustees is to adopt policy, etc. relating to the operation and planning of the Library. Board of Trustees shall establish rules and policies to guide the Library Director; however, in both instances to the provisions of the Town Charter, Town Ordinances and Town's Personnel Policy. The Trustees consist of seven members, each appointed for three year staggered terms. Meetings are held on the fourth Tuesday of the month except in cases of conflict with holidays or other town meetings. At the annual meeting in September, officers are elected.

In 2018, the Trustees worked with the Library Director in cultivating increased collaboration with community organizations, resulting in a growing relationship between the Library and the Gray-New Gloucester High School. The library also grew community relationships by inviting the Town of Gray's Dry Mills School Committee to do a presentation at the Library as part of the annual Pat Barter Speaker Series.

The Trustees aid in the development of Library policies. In 2018, there were no major policy revisions. However, the Trustees did often field questions and provided direction on several operational aspects of the Library.

During the year, the Library Director worked with two Trustees who are actively involved in the marketing field. They held meetings with marketing professionals on how to better position the Library in community to maximize exposure and ensure community members are aware of the resources available at the Library. The project has been ongoing and will continue.

The Trustees have provided support in the following areas:

- Collections of books, e-books and e-audio books.
- Story times
- Adult book groups
- The Pat Barter Speaker Series
- Adult and children movies

Library Trustees provided flowers for the planter under the Library sign and planters by the main entrance. They established Fat Tuesdays on the fourth Tuesday of each month to thank the Library staff with snacks.

ORDINANCE ADVISORY COMMITTEE

for the 2019 Annual Town Report

OAC is a Town Council Committee. Created by the Council to help create new ordinances, refine and revise existing ordinances and to standardize the language of the Town's ordinances.

Topics for the committee to consider generally come from the Council or Town Staff. Work for the committee is also generated by changes in State law, concerns brought to the Council by the Planning Board, or issues that arise from the work of the Town's Planning Department.

The Council prioritizes the committee's work with input from committee and Town Staff. When assigning work to the committee the Council outlines the goals for new ordinances or revisions. The committee's task is to research and proposed language which meets the Council's goals. The committee may ask the Council to clarify or amend its goals based on the committee's findings. The committee may also suggest issues for the Council to consider.

This year has been a challenging one for the committee. The loss of longtime members and difficulty attracting new volunteers meant the committee had difficulty scheduling meetings. Fortunately, volunteers have come forward and the committee is expected to return to its regular meeting schedule next year.

Some of the ordinances and topics the committee worked on this past year are:

- An amendment to the Fireworks ordinance.
- A review of Open Space Sub-Division ordinance with the goal of better defining and improving the quality of the common areas.
- The impact of stormwater and review of our ordinances.
- An update to the No Smoking Ordinance that includes electronic cigarettes.
- A revision to the Kennel Ordinance.
- We reviewed a request by the State of Maine for a change in the Sign Ordinance.
- Amendments to the Street Ordinance.
- Changes to the CZA – Contract Zoning Agreement – process.

The OAC held its first a workshop with the Planning Board to discuss its role and learn how the ordinances impact the Planning Board's work; with an eye to writing well defined ordinances for the Planning Board to implement. We also discussed other issues and concerns that have come up during their work.

Gray Parks & Recreation continues to increase services to school aged children ages 4-12. In the 2018/2019 school year we saw increased participation in all program areas including Kids Club (Before and After School Care), Early Releases Day, Teacher In Service Days, Vacation Camps and Parents Night Out evening events.

Feedback from our current participants suggest we continue to seek out services provided for our Middle School Aged children. This year we added new Parent Night Out options that included two Tween Time (ages 8-12) evening events and a Leaders In Training night (ages 12-15). All three programs were very successful and we look forward to continue feedback that is essential in helping us create fun, engaging, and safe programming for our middle school friends.

PLANNING DEPARTMENT/PLANNING BOARD ANNUAL REPORT 2018

(7/1/18 TO 6/30/19)

Our consistently faithful, volunteer Planning Board members were as follows: Chair Donald Hutchings, Vice Chair Dan Cobb, Richard Bibber, Charlie Abrams, Rachel Lyn Rumson and Paul Myer & our alternate Peter Gellerson. During this time frame, Richard Bibber and Paul Myers moved from Gray and Peter Gellerson transitioned to full voting member. We ended the fiscal year with the five voting members and no alternates. However, in late June two applications for alternates were received and both were appointed to alternate positions and were available for July 2019 PB meetings. Additionally, I would like to thank Jolie Fahey for serving as the recorder of minutes, Grant Guiliano and Brad Fogg for recording and broadcasting the meetings, and Councilors Dan Maguire and Bruce Foshay (alternate) for serving as Council Liaisons. A new recorder, Peggy Brown, will be taking over that role in the next reporting period.

The Staff Review Committee was designed to review smaller projects and consists of the Town Code Enforcement Officer, the Town Planner, and the Planning Board Chair or designee. This committee reviewed three applications which resulted in the following: Approval for a Change of Use/Amendment to a previously approved Site Plan for used car sales on Portland Road, an Amendment to a previously approved Site Plan to allow the owner/applicant to replace two existing mobile homes with cabins at Busy Bee Cabins on Portland Road, and an Amendment to a Previously approved Site Plan to re-develop the structure formerly used as Tee-Em Up golf to an Insurance office. The Staff Review Committee continues to be a great mechanism for reviewing these types of applications that involve minor developments or minor amendments to previously approved projects.

The Planning Board reviewed several applications for Site Plan Reviews for projects which resulted in approvals for the redevelopment of a restaurant into a new Day Care Facility on West Gray Road, an event venue, also on West Gray Road, and a new communications-based business, Dirigo Wireless, on Lewiston Road.

The following subdivisions received final approval during this reporting period: Long Hill Estates 4-lot Subdivision; Portland Road Multi-family (10 units-also subject to Conditional Use and Site Plan Review), and the 30-lot/34 dwelling-unit Woodlands Subdivision. The Long Hill Open Space Subdivision (developing the remaining land of Long Hill Estates) consisting of 26 single family lots and was granted Preliminary Plan Approval during this time frame.

Approval was also granted by the Planning Board for amendments to the following Subdivisions: O'Teri Acres Subdivision and Rolling Hills Subdivision by reconfiguring lot lines, Whitney Ridge Subdivision by the addition of one lot, Long Hill Estates Subdivision and Eagles Nest Subdivision by changes to the method of fire protection, Colley Hill Estates Subdivision by the removal of a view corridor, & Spring Meadows Residential Condominiums by a reduction in the number of units from 20 to 18.

The housing market is continuing to boom in Gray with house and land prices on the rise. The above listed new subdivisions and subdivision amendments resulted in the approval of 48 +/- dwelling units, most of which have not been built yet, and preliminary approval for 25 +/- additional lots. Several lots were sold, and homes were built on subdivision lots that were approved by the Planning Board 10+ years ago, including lots in Eagles Nest Subdivision, Eastfield Estates, Garrison Woods, Gemstone Estates, and Lyons Point.

The Planning Board also acted in their role of monitoring and making recommendations on zoning ordinance as well as hosting a workshop with the Town Council and a workshop with the Ordinance Advisory Committee. There were several ordinance revisions this year and the avenue for Public Hearings for those changes is at the Planning Board meetings. The Planning Board's input is highly valued as they are the entity charged with applying ordinances consistently as applicants submit projects for review to the Board.

Our first intern in the Community Development Department, Rebecca Archer, stayed on through October 2018 and her help with various projects and the 3rd Annual Blueberry Festival was greatly appreciated. A second intern, Douglas Mayo, joined us in June 2019 and has assisted Community Development and other Town Departments with numerous tasks that we simply do not have the staffing to complete without an extra set of hands. I had the pleasure of supervising both interns, and it is an excellent opportunity to help college students fine tune their career paths. Thank you, Rebecca and Doug for helping organize, modernize, and for bringing a youthful perspective to our Town departments. I would also be remiss in not thanking Pam Edson and Brenda Tubbs, our professional assistants in the department. They have different roles but, on most days, they both assist in all areas that co-mingle in our domain at Town Hall, including planning, building & codes, permitting, and assessment.

DEPARTMENT OF PUBLIC WORKS

To the Town Manager, Gray Town Council and the Citizens of Gray:

It is with great pleasure that I submit to you the 2018/2019 Annual Report of the Department of Public Works:

The summer of 2016 and spring of 2017 proved to be busy for the Department. The following roads were paved with one and one-half inches of hot top: 1) Upper Marginal Way, 2) Doughty Farms Road, 3) Southridge, 4) Gore Road, 5) Wildwood Lane, and, 5) May Meadows, for a total of 4,440 tons. After adding shoulders to the above-mentioned roads, the crew spent the rest of the season performing routine maintenance.

The winter of 2018/2019 was a very busy and tough winter. Over the course of the winter we used 3,167 tons of salt, 7,240 yards of sand and 2,350 gallons of calcium. Our first storm was November 16, 2018 and our last storm was April 9, 2019. We had a total of 79.45 inches of snow and several ice storms totaling seven inches of freezing rain, sleet, and ice. We experienced a total of 31 storms, causing 38 different plowing and sanding events and a total of 3,381.5 equipment and man hours. The crew handled the many hours behind the wheel very well, while serving the town with pride and dignity and all answered every one of my frequent calls.

As of July 01, 2019, the Public Works Department Crew consisted of, Arthur St. Cyr, Michael Toderico, Mike Morneau, Alec Dodd, Tim Estes, Vaughn Hutchings and Michael Whittier [Full-Time]. Our part time seasonal crew consists of Chris LaVallee, Glen Mehan, Mike Gordon, Mike Prout, Dan Cummings, Carl Hinkson, Roger Lund, and Bill Stone. All our employees are very important to the Town and Public Works would cease to operate without them. I am proud to be their Department Head and very grateful for their dedication to the Town of Gray.

Congratulations and many thanks to Ed Milose, our Maintenance Supervisor, on his retirement. Thanks to Mo Russo, our new Building and Grounds Director and his staff. Mo's constant support continues to bail us out of many situations.

Once again, I want to thank Chief Kurt Elkanich and the Department of the Public Safety for the many assists during the past year; the two Public Service Departments work many times as one and in very fine fashion. We would also like to thank the Maine State Police, Cumberland County Communication

Center, Cumberland County Sheriff's Department, and Cole Chandler and Nick Mangino, our Town Sheriff's Deputies, for their many assists.

And as always, a big thank-you to all the citizens of Gray who volunteer their time to serve our departments and committees and to all the citizens who show courtesy towards our department as we strive to improve the safety of our Town ways. And last, but not least to Tom, Pam, Judy, Galen, Katy, Kathy, and Doug, whose constant support makes my job much easier.

RECYCLING COMMITTEE

*Annual Report to the Town Council
June 1, 2018-June 1, 2019*

The Duties of the Recycling Committee are:

1. The Committee shall review changes in state, regional, and Federal recycling policy and law and make recommendations as appropriate to modify Gray's current policies.
2. The Committee shall make recommendations and work with the Town Council and Town staff to develop changes to our recycling and solid waste program as necessary.
3. The Committee shall work with the Solid Waste Director to promote budgetary items to the Town Council that will enhance and/or reduce cost of operation.
4. The Committee shall promote and publicize recycling and waste reduction.
5. The Committee shall encourage Town businesses to bring their recyclables to our recycling center.
6. The Committee shall encourage, and work with other recycling committees, to identify and develop local, regional, and national markets to deal with recyclable materials.

The Committee was able to achieve many goals this past year.

1. Participated in the Blueberry Festival on August 11th, 2018 with a blue tarp activity designed to educate participants on what can and cannot be recycled.
2. Assisted with the Annual Hazardous Waste Day on August 25th, 2018
3. Participated in several Educational presentations at the Middle and High School helping to educate students on the Transfer Station and Recycling Do's and Don'ts
4. Reviewed the existing Transfer Station Fee Schedule against current contract pricing and fees being charged in other Communities to determine recommended changes. The Council adopted the recommendations on June 18th, 2019.
5. Established a new "Recycling Corner" in the Town's Monthly Newsletter with a focus on educating residents via more detailed reviews of individual items. This new column was also used to communicate changes in the Transfer Station Fee schedule.
6. Started a conversation with residents on composting via hosting a Vermicomposting company at the Gray Public Library on June 8th, 2019.

Although a lot was accomplished in 2018-19, the long standing Recyclopedia Project remained unfinished with additional work moving us closer to completion. More critically, the loss of volunteers impacted the Committee's ability to meet as planned on several occasions and eventually lead to the dissolution of the existing Committee.

New members have stepped forward and (3) will be confirmed to start the new cycle (Aug 2019). This creates a great opportunity to recreate and renew the Committee.

The committee's goals for 2019-20 are:

1. Recruit additional members until the Committee is full.
2. Continue the Recycling Corner monthly column.
3. Review the existing charge, goals and duties of the Recycling Committee for updates.
4. Complete the Recyclopedia Project and develop a roll-out communication plan.
5. Identify ways to increase recycling or reduce waste within the Community.

SOLID WASTE AND RECYCLING

Greetings:

It is with pleasure that I submit to you this brief summary of issues affecting the Solid Waste Department in Fiscal Year 2019, and potential influences for FY 2020.

A consistent outlet has been secured for the wood waste collected at the transfer station; though not ideal nor inexpensive, it is an outlet. The mills to which it had been sent in previous years have become intensely stringent on content making the testing required too expensive. The wood waste now is being shredded and used as daily cover on landfills thus reducing the amount of testing required, lowering costs. This in no way reduces the importance of keeping the wood pile clean. There are plenty of State restrictions on what can be included, and inspections are random.

Plastic and paper markets remain in a slump due to the ban on import of these materials in China and throughout Asia, previously the biggest buyers. I expect this downturn to continue for another 2 – 3 years while domestic mills are being built or revamped to handle the glut of these products.

An issue regarding the safety and well-being of staff at the transfer station continues to arise – the improper disposal of hypodermic needles. While it is understood that the use of these needles is crucial to many in our community, the improper disposal puts staff at risk. To dispose of these needles properly simply use a heavy detergent bottle (we have plenty available if necessary), place the needles inside and, when full, duct tape the cover closed, label as SHARPS, and dispose of in the regular household trash. This almost totally eliminates the possibility of inadvertent contact by others.

Expect to see unavoidable increases in disposal fees in FY 2020 as costs to the Town are set to rise significantly for hauling and disposal. Rather than the entire tax base be forced to absorb these increases, costs will be borne by those using the service.

I cannot stress enough the importance of recycling even in this downturn in the market. Recycling is still less expensive than throwing it away. Thanks for doing your part. Keep recycling!

As always, in closing I would like to thank my staff for their dedication to their job through the cold of winter and heat of summer, the volunteers who give so much of their time in keeping the “Take it or Leave it” shop organized, the Recycling Committee for their assistance throughout the year, and you, the residents of Gray for your continued support, kindness, and for allowing me to be at your service.

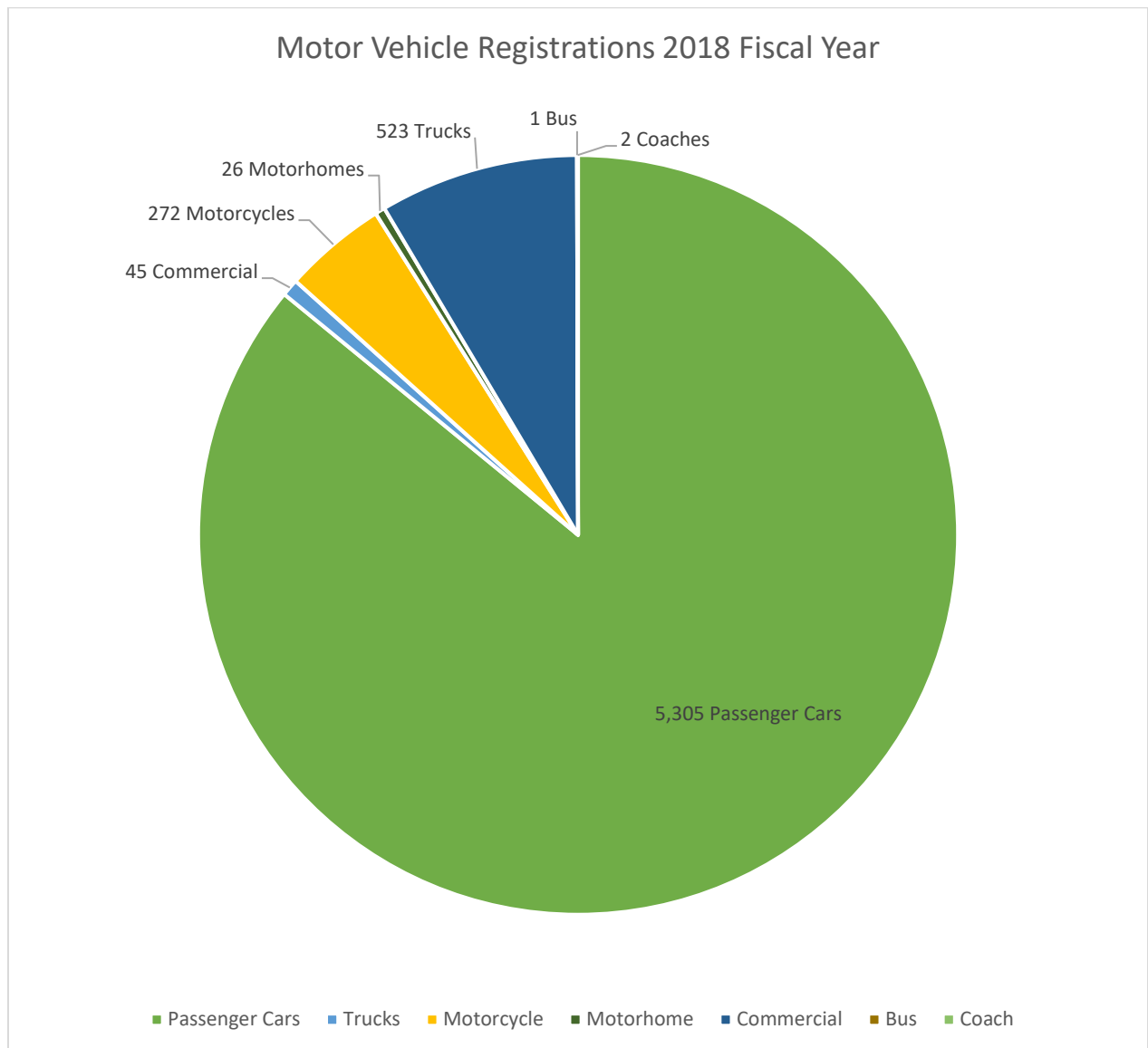

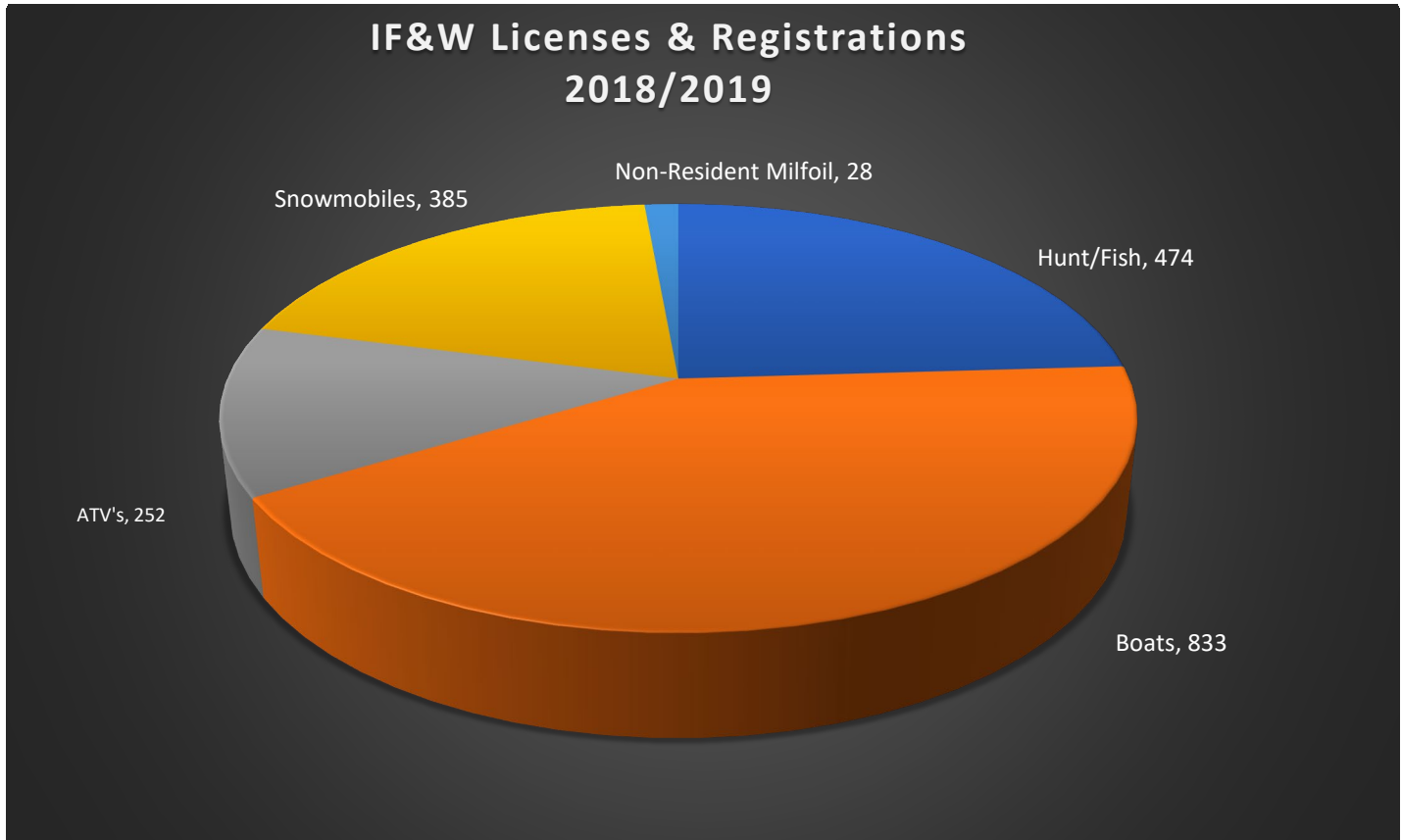
